Hello fellow residents:

It's that time of year to start thinking about winter. Charlie and John have done a good job getting the roads in shape, so we have a good base to start. They will be starting to get plows and spreaders ready soon.

I have had an inquiry as to what size a storage shed needs to be before it becomes taxable. I spoke with the assessor and was told any building 100 square feet and over is taxable. For example, a 10' x 10' building is 100 square feet in size. If you are thinking about buying a building this size or bigger, it will be taxable. A building 1,000 square feet or bigger, you will need a building permit. All of the permit information is on the township website.

I would like to mention a couple of issues that we have been experiencing at the recreation complex. Please note that the recycling bins are not for TVs, computers, household appliances, tires, auto parts, and paint cans. Also, the dumpster next to the concession stand is not for public use, but is for the recreation area only. If caught dumping there, you will be prosecuted for littering. We are presently considering the use of cameras to help control this problem. Please do not abuse this service.

It has been a busy spring and summer season. I want to thank Charlie, John, Dan and Gene for all of their hard work. Be safe.

Hello everyone:

It's hard to believe it's fall already! This year has gone by so fast. John and I have had a busy summer with grant projects to regular road maintenance. I guess time goes by quickly when you are getting things done. The Jouver Road grant project was completed this year. With extra additions to the project and weather not being so kind, we still came in around \$7,000 under budget with the project. The Mercer Road project is underway, however, it doesn't look to be completed this year due to permit issues. We have also had a productive year with berming and in some areas, hogging to create water shed. Even though we haven't had a lot of rain this year, this will help in the future as well as the spring thaw time.

Grading, mowing, and trimming of the trees will be the goal for the fall. We hope to get some of the trees cut back out of the roadway, including yard trees.

September 9th makes six years that I have been here. Hopefully, you can all see the difference in the township from the grant projects totaling over \$400,000 to date and to the road maintenance itself. My partners and I are proud of what we have accomplished and look forward to continuing our service to the people of this township.
