With winter approaching, we will be getting equipment ready for snow removal and taking care of any issues that arise to make sure we're ready to handle what Mother Nature throws our way. Let's hope that we have an easy winter similar to the one we had last year.

Any resident thinking of selling a parcel of land in Crawford County needs to remember that the county has enacted a UPI ordinance. This is a Uniform Parcel Identifier. This requires that every document recorded with the county recorder of deeds has to have a UPI certified by the county assessment office. This can take up to 3 days, and there is a \$20.00 fee involved. Please be sure to contact the county assessment office for any clarification at (814) 333-7302.

We are continuing to work with the supervisors trying to streamline our existing ordinances as needed. Please remember, when considering a building project, to contact the township office with any questions. Thank you.
