Quotes for diesel – Telephone quotes were received for on road diesel: Melzer's Fuel Service for \$2.65/gal, Klasen for \$3.019/gal, Reed Oil for \$2.94/gal.

**Motion made by Potts, seconded by Sharpe, to purchase on road diesel from Melzer's Fuel Service for 2025. Motion carried; three ayes.

Equipment updates – Both Grasshopper mowers need serviced. John will contact Greenhill Farms to come to pick them up.

Fuel pump update for diesel tank – The meter has been put on the fuel pump.

Road concerns- The roads have been maintained well considering the weather.

New Business:

World of Mazes cabins – There was an article in the paper on January 25th. Chuck said that he is planning to remove the cabins that are there. He would like to put in commercial restrooms with cottages on the property. Cottages would be rented out on the weekends.

County SALDO proposal – Potts attended the Subdivision and Land Development Ordinance meeting last week. John Lawrence is recommending that Richmond Township creates their own SALDO before the County SALDO comes into effect. Also, Potts recommends that a letter be drafted from our township with our letterhead expressing the concerns with the County SALDO ordinance.

Possible grants –

- 1) Castile Road bridge we will investigate possibilities
- 2) WWII arch memorial Potts has been working with Betty Tomer in writing grants. The LOWE's grant is available. We will also look at soliciting funds from the community.
- 3) Playground we can apply for the DCNR grant

Increase in rental fees at the Recreation Complex – Anyone who already has rentals lined up this year will remain at the current price for this year.

**Motion made by Potts, seconded by Sharpe, to increase the pavilion rentals to \$75/day and the building rental to \$125/day. Motion carried; three ayes.

Possible ordinance for newly constructed utilities on John Brown Rd – At the Planning Commission meeting, it was suggested that an ordinance be passed that prohibited any utility lines from being constructed over the tannery area. Potts feels that this is not necessary as we could address the situation prior to the construction, as well as any landowner has the right to see the proposal before that construction happens.

Change primary BCO -

**Motion made by Potts, seconded by Sharpe, to change the township's primary BCO to Ian Gorske. Motion carried; three ayes.

Positions up for re-election – We need an auditor and a supervisor. Kathleen Wheelock is running for tax collector.

2025 PSATS Convention – Bob Potts is willing to go. And we will have the same per diem as last year. **Spring Newsletter** – Information is needed for the newsletter. Please send info by March meeting.
