Deposits are non-refundable. The Breeder will provide a 26-month HIP and EYE GUARANTEE at the time of sale. Breeder makes no guarantee on the physical characteristics of these puppies. Puppies come with 1st Vaccinations, de-wormed, micro-chipped and AKC registered.

Puppies must be checked by their vet within 7 days of going to their new home. It is impossible to state that a puppy will be completely free of genetic imperfections. In our breeding program, we only breed females with an OFA rating of FAIR, GOOD or EXCELLENT and EYE rating of NORMAL and to males certified with an OFA rating of GOOD or EXCELLENT and EYE rating of NORMAL. We feel that by adhering to these standards, we are reducing the risk of producing a defective puppy or litter. Therefore, we offer this HIP and EYE guarantee, providing that the buyer complies with this agreement. No other conditions apply to this contract.

Puppies will only be held past the date of eight (8) weeks of age by prior arrangement. Breeder may sell any puppy held past the date of nine (9) weeks of age (unless prior arrangement has been made) with Buyer forfeiting deposit and all claims to the puppy. If the puppy has been paid in full, Breeder will return the purchase price, minus the deposit. Any expenses incurred by Breeder shall be deducted from any returned monies owed to Buyer.

****Buyer must sign and return one copy to Shamrock Labradors.****

The Buyer agrees to have a registered name chosen at time of pick-up for the puppy to be AKC Registered before leaving Shamrock Labradors premises. If a registered name is not chosen, Shamrock Labradors reserves the right to choose one for registration purposes before the puppy leaves. Registration fee is included in the price of the puppy.

Before a puppy leaves our premises, the Buyer agrees to have a microchip registered in their name through AKC REUNITE with Shamrock Labradors being listed as 2nd contact. This will help us ensure the safety of the puppy. Registration fee is included in the price of the puppy.

By completing this document, you are agreeing to the following:

- The purchase of the above stated puppy.
- To pay the balance in full when picking up your puppy if you have not already done so.
- To pick up your puppy no later than one week after the date stating when the puppy is ready to go home unless other arrangements are agreed upon.
