The purpose of this directive is to establish a policy concerning a Code of Conduct that will serve to promote efficiency, discipline, and good public relations for all members of the sheriff's office. Any reference to a "member" shall encompass sworn, non-sworn, and volunteers throughout this general order.

# I. Obligations to Know and Abide by the Laws, Regulations, Objectives and Orders of the Sheriff's Office

- A. Every member shall know and abide by the laws relating to the protection of civil liberties and applicable restraints upon governmental power. The moral and legal basis for the exercise of police power is liberty under the law. Illegal exercise of this power erodes the foundation of government.
- B. Members shall, to the extent required by their assignment, know the criminal law provided by state statutes and local ordinances, as well as those specified by the sheriff's office directives, orders, regulations, and bulletins.
- C. All members shall adhere to all federal, state, county, and municipal laws.
- D. Members of the sheriff's office shall abide by the rules of conduct as set forth in all written directives of the sheriff's office. Any violation of these or other regulations may result in disciplinary action.
- E. Members must abide by and strive to meet the objectives of the sheriff's office.

- Members shall preserve the public peace, detect and arrest offenders, prevent crime, protect life and property, and enforce the ordinances of Clay County and statutes of the State of Florida and the United States.
- Members shall serve the public by direction, counsel, and other ways that will not interfere with the discharge of their law enforcement responsibility. They shall respect and protect the rights of individuals and perform their services with honesty, zeal, courage, discretion, fidelity, and sound judgment. Members shall not, however, make specific commitments to members of the public, which would tend to commit the sheriff's office to special obligations to any individual members of the public.
- Non-sworn members, although not personally responsible for enforcement of the law, shall provide support for the sheriff's office's basic mission.
- F. All members must obey orders.
  - Members will obey lawful orders of a ranking member. Orders known to be unlawful shall not be obeyed. Obedience to an order known to be unlawful is no defense against legal or disciplinary action. Any member refusing to obey an order will be required to justify the refusal.
  - A member that is given an order that is in conflict with previous orders, regulations, directives, or manuals shall respectfully inform the ranking member issuing the order in conflict. If the superior member issuing the order does not alter or retract the conflicting order, the member shall comply unless it is a violation of the law. Under these circumstances, the responsibility shall be upon the ranking member. The member obeying the conflicting order shall not be held responsible for disobedience of the order previously issued.
  - All members shall cooperate fully with any investigation of violations of sheriff's office rules and regulations. This may include, under appropriate circumstances, submission to medical testing as ordered by the appropriate authority.
  - 4. A member under investigation for a criminal offense does not waive any of their constitutional rights regarding self-incrimination. The member will be advised if they are under investigation for a criminal matter, and the fact that they are employed by this agency does not compel cooperation with a criminal investigation. The member will be advised that they are not required to make a statement, but can offer a voluntary statement if the member wishes to do so. To ensure compliance with this requirement, the member under investigation will be provided the warnings. Miranda warnings will be provided if the member is subject to custodial interrogation as set forth in applicable case law.
  - When a member is the subject of a criminal investigation, that investigation will be handled/worked by the Integrity Investigator or investigator appointed by the Sheriff or Undersheriff.

### II. Obligations to Demonstrate Courtesy and Cooperation

- A. Public and internal support of sheriff's office activities is imperative if the objectives of suppressing criminal activities and providing security for the community are to be accomplished.
- B. Public and internal cooperation and support can be generated best through satisfactory public and interpersonal contacts.
- C. Public contacts Members shall be responsive to the needs of the public by rendering prompt and courteous service and consistently conducting themselves in a manner that encourages public respect.
- D. Personal contacts Members shall strive to treat victims, witnesses, suspects, arrested persons, and all other contacts with respect. Personal prejudices or attitudes, which may influence impartiality, shall be suppressed. When requested by the public, members shall identify themselves by name, rank, and identification number unless doing so would compromise their assignment.
- E. Telephone contacts Members shall, at all times, maintain a courteous and professional telephone demeanor when dealing with the public, with members of other agencies, and within the sheriff's office.
- F. Other agency contacts Members shall support other law enforcement agencies in their pursuit of lawful activities without interfering with those agencies' cases, work, or operation.
  - Members of the sheriff's office will cooperate with, support, and assist employees from other law enforcement agencies in the performance of their official duties. If a member must initiate law enforcement action against any member of another law enforcement agency, the member shall notify their supervisor immediately, who will notify the on-duty watch commander.
  - Complaints against other law enforcement or related agencies will be channeled through the member's chain of command so that appropriate action may be taken. Public criticism of other agencies, the courts, or disposition of cases is prohibited.
- G. Courtesy to and support of co-workers.
  - Members are required to perform their duties in a cooperative and supportive manner.
  - Members shall be courteous, civil, and otherwise act with respect towards one another. They shall not publicly criticize any official act or member of the sheriff's office.
  - Members shall not use disrespectful, mutinous, insolent, or abusive language toward a supervisor or any other member.

 In front of the public, members shall address one another by use of their titles and last names and will not use first names or nicknames.

## III. Constraints on Behavior (CFA 7.08M/FMJS 3.2 a, b, e, g)

A. Purpose of constraints on behavior - Members must recognize that certain constraints on their behavior arise from their role in society. The underlying purpose of such constraints is to nurture general confidence in the law enforcement system by fostering exemplary personal conduct and fairness in matters of social or political interaction. Member's actions have a symbolic importance, reaching beyond the immediate consequence. Acceptance of these obligations will multiply the sheriff's office contributions to the wellbeing of the community served.

#### B. Information

- Members shall not impart official information of a confidential nature to anyone except those for whom it is intended or as directed by their supervisor or under due process of law. They shall not reveal the identity of a complainant or informant to any private person unless directed to do so by their supervisor or higher authority.
- Members shall not communicate information, which may impede an investigation, delay an arrest, aid a person to escape, destroy evidence, or remove stolen goods.
- Members shall not communicate information relating to proposed arrests or cases under investigation or to be investigated, except to the member assigned to the case, a supervisor, or unless authorized by a higher authority.
- Members shall obtain permission from the Sheriff before publishing articles as official representatives. No member shall act as a correspondent to any news media unless authorized by the Sheriff.
- Members shall not give out publicity concerning federal prisoners. They shall not give out personal history or photographs of federal prisoners, information as to arrival or departure of such prisoners, or permit reporters to interview them. Any inquiries concerning federal prisoners will be referred to the federal authorities for whom the prisoner is being held.
- 6. All official and unofficial correspondence received shall be processed as directed by the Sheriff. All outgoing correspondence shall be sent over the name of the Sheriff. Members shall not use official letterhead except for authorized sheriff's office correspondence and still send over the name of the Sheriff in accordance with current policy on outgoing correspondence.
- C. Intoxicants, drugs, and tobacco

- The Clay County Detention Facility and all other Clay County Sheriff's Office facilities are designated as "tobacco-free facilities." Tobacco (smoking or smokeless to include vaping) shall not be used by the sheriff's office members on-duty and in public view or off-duty and in uniform. Members shall exercise discretion in the use of tobacco. Members will comply with all statutes and ordinances concerning the use of tobacco. The use of tobacco is prohibited inside any public governmental building. The use of tobacco is also prohibited while inside a sheriff's office-owned or leased vehicle.
- Members shall not purchase or drink alcoholic beverages while in uniform. On-duty members shall not purchase or drink alcoholic beverages unless authorized or required for the performance of assigned duties, nor shall they report for any tour of duty under the influence of alcohol. Off-duty members shall not drink alcohol to the point of impairment and drive, get involved in a disturbance, or try to take law enforcement action.
- 3. Any illegal use of prescription drugs or use of illegal drugs that would be considered illegal by Florida State Statute(s) will be cause for disciplinary action, possibly resulting in dismissal. No member will use prescription drugs to the extent that such use interferes with their duties. When taking medications or using therapeutic treatments that impair or could impair performance, members must inform their supervisor prior to starting duty.

#### D. Civil cases

- Members shall not involve themselves in the civil actions or disputes of other persons, nor shall they presume to adjudicate any civil dispute or force the settlement of, or in any way influence a civil matter. They shall not give legal advice in civil matters. Members of the sheriff's office shall not recommend or suggest to any person arrested, or any prisoner, or any other person, the employment or hire of any person as an attorney or counsel, either directly or indirectly. Members are permitted to make recommendations to members of their own families.
- When called upon to act or advise in such disputes, a member shall respectfully inform the interested parties that the sheriff's office has no jurisdiction in civil disputes and shall when requested, refer them to proper authorities for assistance.
- A member, however, shall act to prevent or suppress any breach of peace or disturbance which may grow or has grown out of such a dispute.
- Members shall not testify in civil cases unless legally summoned, except when appearing as a witness on behalf of Clay County or in a civil suit on their own behalf.
- Members shall furnish notification, in writing, of their intent to file a suit arising out of their official duties in any court of law to the Sheriff not less than five (5) days before the actual filing date. Members shall not accept

anything as payment for personal injury or property damage incurred in the line of duty without first notifying the Sheriff. Members shall not use their official position as a means of forcing or intimidating persons with whom they are engaged in a civil controversy to settle the case in favor of the member.

6. Members who have a damage suit filed against them by reason of acts performed by them in the line of duty shall immediately notify their immediate supervisor in writing, who in turn shall notify the Sheriff in writing via the chain of command.

### E. Outside activities

#### 1. Political Activities

- a. Florida State Statute, FSS 99.012, requires that any individual who is subordinate personnel, a deputy sheriff or a police officer, resign if seeking to qualify for a public office which is currently held by an individual who has the authority to appoint, employ, promote, or otherwise supervise the individual and has qualified for reelection to that office.
- b. Any member who participates in any political campaign shall engage in such activity only while off-duty. A member may use accumulated annual/PTO or compensatory leave to comply with this section.
- c. In accordance with FSS 104.31, no member of the Clay County Sheriff's Office shall:
  - (1) Use their official authority or influence for the purpose of interfering with an election or a nomination of office or coercing or influencing another person's vote or affecting the result thereof;
  - (2) Directly or indirectly attempt to coerce, command, or advise any other agency member to pay, lend, or contribute any part of their salary, or any money, or anything else of value to any party, committee, organization, agency, or person for political purposes;
  - (3) Directly or indirectly coerce or attempt to coerce, command, and advise any agency member as to where they might purchase commodities or to interfere in any other way with the personal right of any member; or
  - (4) With the exception of the Sheriff, participate in any political campaign for elective office while on duty.
- If members give testimonials or permit their names or photographs to be used for advertising or endorsement purposes, they shall not reflect or

infer their employment with the sheriff's office unless written permission is obtained from the Sheriff.

- 3. Members are forbidden to solicit, petition, or offer gratuities for: their promotion, change of duty assignment, or retirement; the promotion, change of duty assignment, or retirement for any other member; the appointment of any member to the sheriff's office; or to promote any influence to affect such an end.
- 4. Members are prohibited from engaging in any strike or work stoppage. FSS 447.505 provides that, "No public employee or employee organization may participate in a strike against a public employer by instigating or supporting, in any manner, a strike. Any violation of this section shall subject the violator to the penalties provided in this part."
- All requests for members to speak to any public or private group as a representative of the sheriff's office shall be referred to their division chief.

Exceptions: Members assigned to the Community Affairs Section or Police Activities League are exempt while conducting their on-duty assignment.

### 6. Lobbying:

- a. No member shall engage in lobbying activity on behalf of the Clay County Sheriff's Office before any public body without the permission of the Sheriff.
- b. Any approved lobbying activity will be in accordance with FSS 112.313.

### Board of County Commissioners:

- a. There may be times when members are called upon to present and/or bring new proposals/ordinances to the Board of County Commissioners. All members must receive prior approval before doing so.
- b. Members must submit an "Intention to Put Forth Agency Item(s) at the Clay County Board of County Commissioners/Subcommittees" form (A448) through their chain of command. The Senior Executive Assistant will maintain a log of all requests.

### F. Abuse of position or authority:

1. Members shall not become involved in any promises or arrangements which are intended to reduce the charges and permit the offender to escape the full penalty provided by the law without obtaining an approval of a request for intervention from the Sheriff.

- Members shall not interfere unnecessarily with any case assigned to another member, with the operation of any other zone or of the courts, or with any lawful private enterprise.
- Members of the sheriff's office shall refrain from recommending any business firms while acting in their official capacity. Members shall not threaten a law-abiding citizen in the lawful pursuit of a legitimate business.
- 4. Members shall not solicit or accept presents, loans, or gratuities while on or off duty if it intends to influence the discharge of official duties or if it involves any governmental action affecting the owner or lender. A member may accept a reward with the written approval of the Sheriff. A member shall not receive a reward offered by the state or county as they are already charged with the duty of apprehending such a violator. This policy is intended to set a pattern of conduct whereby members will not indulge in the acceptance of gratuities, no matter how small, which may raise questions of favoritism in the discharge of official duties.
- Members shall not use their official position to solicit special privileges for themselves or others. A member may use their badge/ID to obtain admission to any public gathering only in the furtherance of their official duty. (This excludes special offers given to or endorsed by the sheriff's office or private entities for discounted offers or services).
- 6. Members shall not receive any article whatsoever (either as a gift or as the result of purchase or trade) from suspects, prisoners, persons recently arrested; known gamblers, prostitutes or other persons of bad character or ill repute; professional bondsmen or other persons who may profit from information obtained from the members; relatives, members, or associates of any of these persons. Nor shall members sell any article to such persons.
  - a. Members of the sheriff's office shall not recommend or suggest, either directly or indirectly to any person arrested, incarcerated, or any other person, the name of any bail bondsmen.
  - b. Members of the sheriff's office shall not become surety or guarantor; furnish bail or bond for any person arrested for a crime, except for members of their immediate family. In this circumstance, the member will notify their department director via memorandum (A054).
- No member shall prevent or attempt to prevent any traffic citation or misdemeanor citation from adhering to established judicial process, except in cases where a traffic or misdemeanor citation has been unlawfully issued or issued in error. A lieutenant or above or the member who issued such traffic or misdemeanor citation shall have the authority to recommend that said traffic or misdemeanor citation be voided. The affected member's division chief must review and approve the said recommendation. If a traffic or misdemeanor citation has been issued

erroneously, the issuing member shall correct or amend said charges and see that the party to whom such traffic or citation was issued is notified of such correction or amendment.

- 8. Mentally or physically abusing any arrestee/inmate in custody or the use of unnecessary force in making an arrest or handling of an inmate is prohibited.
- 9. Members are prohibited from suggesting or recommending wrecker services or agencies for persons involved in traffic crashes or other incidents requiring the services of a wrecker. It shall be the automobile owner's prerogative to name the wrecker service desired, and the member then is obligated to make every effort to secure the wrecker named for the owner. Should the wrecker desired not be available, or the person has no preference, the sheriff's office will secure the services from the wrecker service company that is on the rotation list for the next call.
- Members shall not knowingly associate or fraternize with, correspond or communicate with, engage in criminal activity or accept services from or do favors for any detained, sentenced or pretrial inmate, or their family members charged to the custody of the Sheriff except as necessary to perform their duty functions as set forth by the rules and regulations.

Exception: Members assigned or conducting an investigation authorized by their chain of command.

- G. Unbecoming, immoral or detrimental conduct
  - Members shall conduct themselves at all times, both on and off-duty, in such a manner as to reflect favorably on the sheriff's office. Unbecoming conduct shall include that which brings the sheriff's office into disrepute or reflects discredit upon the member of the sheriff's office or that which impairs the operation or efficiency of the sheriff's office.
  - Members shall not participate in any deviate, immoral, indecent, lewd, or disorderly conduct.
  - Members shall not, whether on or off-duty, engage in actions that tend to impair the operations of the sheriff's office and its efficiency or adversely affect the sheriff's office reputation in the community.
  - Examples of prohibited conduct include, but are not limited to:
    - a. Interfering with another member's ability to carry out that member's duties and responsibilities
    - b. Interfering with the ability of supervisors to maintain discipline
    - c. Willfully departing from the truth

- Accepting employment or engaging in any business which, in the opinion of the Sheriff or designee, interferes with the efficient performance of one's regular law enforcement employment
- e. Publicly criticizing the office of the sheriff (sheriff's office) or its policies, programs, actions, or members
- f. Performing or making any verbal or written statements that may bring the office of the sheriff (sheriff's office) into disrepute or ridicule
- g. Speaking disparagingly about any other member, or defacing or demeaning the nationality, creed, race, or sex of any person
- h. Intimidating persons for personal reason under color of authority
- Appropriating any lost or found property or evidence to one's own use
- j. Sleeping while on duty
- k. Aiding or abetting the escape of a prisoner
- Accepting or soliciting a bribe
- m. Handling county or sheriff's office property roughly or carelessly
- n. Feigning sickness or injury to escape duty
- o. Falsifying sheriff's office reports, records, or communications
- p. Engaging in controversies or making arrests in one's own disputes or in those within one's family, or in disputes arising with one's neighbors, except under such circumstances as would justify self-defense or to prevent injury to another, or when a serious offense has been committed, or in the performance of an approved secondary employment situation
- q. Affiliating with any organization or body, the provisions of the charter or by-laws of which would in any way prevent a member from performing their duties
- Failing to communicate information of concern to the sheriff's office regarding a law enforcement case being handled by another member
- Using sheriff's office property in the conduct of one's personal or private affairs without authorization
- t. Commission of a criminal act in violation of a county, state, or federal statute

- u. Willful refusal or failure to appear before any court, judge, prosecuting officer, board, or body authorized to conduct any hearing or inquiry in any investigation for a violation of any of the statutes of this state or sheriff's office general orders or procedures when requested to do so
- v. Failure to complete reports promptly and in the manner prescribed by reporting procedure. They shall not make any false report, whether orally or in writing. Members who receive assistance from other members on a case to which they are assigned shall note the assistance on their report.
- Failure to complete a report on all crimes, suicides and their W. attempts, important happenings, or other information of concern that comes to their attention. They shall not repress, conceal or distort the facts of any such incident. Members who have reason to believe that a building or part thereof is being used in violation of the law or as the resort or residence of persons of questionable character, or that liquor, narcotic, prostitution, or gambling laws are being violated, or who have information regarding any felony or any wanted person, shall immediately report all details to their supervisor, who shall direct the action to be taken or forward the information to the proper department. However, any member of the sheriff's office who has valuable information regarding an arrest in a police case other than their own shall communicate such information to the arresting investigating member directly or in writing through official channels. If such a report is not made, it shall be deemed neglect of duty to withhold such information.
- x. A member shall not engage in any activity that would constitute a conflict of interest with the Clay County Sheriff's Office.
- Refusal to pay just debts and liabilities
- z. Give testimonials or permit their names or photographs to be used for advertising purposes. Members shall not seek publicity in the public press.
- Willful neglect or refusal to obey any proper legal order of a superior officer
- bb. Willful neglect to perform any duty in the manner required by rules and regulations, rules of duty, or rules of procedure
- Conduct unbecoming an officer and a gentleman/lady, which may be specifically set forth in these rules and regulations. Any act not listed which may not be found to be in violation of the sheriff's office general orders and/or Florida State Statute.
- 6. Any member who feels that they have been injured or discredited by a superior officer through unreasonable, unjust, arbitrary, capricious,

tyrannical conduct or abusive language, or any member having a grievance against another member shall initiate their grievance in writing and direct the same, via chain-of-command to the Sheriff, who shall investigate and make a written reply to the aggrieved.

- 7. Members shall not have an unprofessional relationship with an inmate, detainee, probationer, or community controlee. An unprofessional relationship is defined as:
  - Having written or oral communication with an inmate or detainee that is intended to facilitate improper physical contact or a romantic association, or
  - b. Engaging in physical contact not required in the performance of office duties, and is defined as kissing, fondling of the genital area, buttocks, or breasts, massaging or similar touching, holding hands, or any other physical contact normally associated with the demonstration of affection or sexual conduct, or
  - c. Engaging in a romantic association with an inmate or detainee. "Romantic Association" is defined as the exchange of telephone calls, pictures, letters, greeting cards, emails, texts, or any other form of oral or written communication, which expresses feelings or thoughts of affection or the desire to engage in a romantic relationship whether emotional or physical. This subsection does not apply to a member who is legally married to an inmate, detainee, probationer, or community controlee, nor to a member who has no knowledge, or reason to believe, that the person with whom the member has engaged in a romantic association is an inmate, detainee, probationer, or community controlee.
- H. Members shall avoid regular or continuous associations or dealings with persons who they know are under criminal investigation or prosecution, except as required by the performance of their duties, or where unavoidable, because of a personal relationship of the member. "Personal relationships" are defined as those relationships created by blood or marriage.

### IV. Performance of Duty (FMJS 3.2, c)

- A. Competence Members shall maintain sufficient competence to properly perform their duties and to assume the responsibilities of their positions. They shall perform their duties in a manner that will tend to establish and maintain the highest standards of efficiency in carrying out the functions and objectives of the sheriff's office. Incompetency may be demonstrated by:
  - A lack of knowledge of the application of law required to be enforced
  - 2. An unwillingness or inability to perform assigned tasks or duties
  - The failure to conform to work standards established for the member's rank, grade, or position

- 4. Failure to take appropriate action on the occasion of a crime, disorder, or other condition deserving law enforcement attention
- 5. Leave without permission
- Unexcused absence from the member's assigned work schedule
- A record of repeated infractions of the rules, regulations, procedures, or directives
- B. Reporting for duty All members, sworn and non-sworn, shall report promptly at the designated time and place for work, roll call, assignment or duties, and/or inspection. This includes but is not limited to the following: i.e., proper dress, equipment cleaned, functioning and accounted for, issued/assigned vehicle cleaned and fueled, etc.
- C. While on duty
  - Members shall devote their time and attention to fulfilling their duties and responsibilities.
  - On-duty members shall maintain command of temper, patience, and discretion, and refrain from course, profane, or insolent language.
  - Members shall not have any unauthorized keys to any area of the facilities operated by the Clay County Sheriff's Office.
  - 4. Members shall be attentive to and take suitable action on reports and complaints by a citizen, except when circumstances make it necessary for them to report the matter or refer the complaint to a more appropriate member or other agency. Members shall fulfill proper requests for information or assistance; or, they shall aid the person otherwise obtaining the requested information or assistance. Members shall avoid giving impressions that they are not interested in the problems of persons who are referred elsewhere for service. Members shall not belittle a seemingly trivial request, complaint, or item of information received.
  - 5. Any member who willfully or negligently loses, damages, or destroys sheriff's office property or equipment may be subject to disciplinary action and/or criminal prosecution.
  - Members shall remain at their place of assignment until properly relieved or dismissed from the responsibility by a supervisor or an assigned relief.
- D. Continuing authority to act Off-duty members shall possess the same law enforcement and arrest authority as when on-duty and shall have the authority to act in an official capacity when the circumstances warrant law enforcement action.

## V. Contact with Persons in Custody (FMJS 3.2, d, e, f, g, 3.4)

A. Each member's conduct shall at all times be consistent with the maintenance of proper security and welfare of the facility and of the inmates under the member's supervision. Members are to acquaint themselves with the general orders and standard operating procedures concerning this subject and govern themselves accordingly.

### B. No Member Shall:

- Threaten, intimidate or otherwise harass or retaliate against an inmate for complaining about treatment or conditions of confinement, reporting abuse, filing or seeking to file a grievance, communicating with counsel, or seeking redress through the courts
- Trade, barter with, or accept anything of value from an inmate, their friends, or family. Exception as provided in the policy and procedure directives for the facility
- Introduce into or remove from the property of any detention facility any article without authorization from the Chief of Detention Security, Director of Detention, or designee
- 4. Recommend or furnish any legal advice or any other advice concerning the selection of a specified lawyer/bonds person for an inmate. If requested by an inmate, a directory or list of names of all area lawyers or bonds persons should be made available for the inmate's use
- Knowingly permit any subordinate, inmate, or other person to commit any act or engage in any conduct, which would violate the rules and regulations of this facility
- 6. Allow inmates to supervise, have control, or assume any authority over other inmates
- Give out personal history or photographs of federal prisoners, information as to the arrival or departure of such prisoners, or permit reporters to interview them
- 8. Allow escape because of carelessness or neglect of duty
- 9. Fail to collect and identify any found contraband
- Loan, sell, or give away any personal items or property to any sentenced or pretrial inmate in custody unless it is approved by the Director of Detention

### VI. Social Media Use

Members shall not use any agency equipment or resources to engage in social

- media activities unless expressly allowed by a supervisor in the discharge of official duties.
- B. Members shall not make statements about the guilt or innocence of any suspect, inmate, arrestee; comments concerning pending investigations and/or prosecutions; nor post, transmit or otherwise disseminate confidential information, including photographs or videos, related to Clay County Sheriff's Office training, activities, or work-related assignments without expressed written permission from the Sheriff or designee.
- C. Members are free to express themselves as private citizens on social media sites to the degree that their speech does not impair the work of the Clay County Sheriff's Office; damage the reputation of another; disparage or embarrass the agency, its members, or any of its business units or functions. Clay County Sheriff's Office members are cautioned that speech, on or off-duty, made pursuant to their official duties is not protected speech under the First Amendment and may form the basis for discipline if deemed detrimental to the Clay County Sheriff's Office. Members are particularly prohibited from the following:
  - Speech containing obscene or sexually explicit language, images, or acts and statements or other forms of speech that ridicule, malign, disparage, or otherwise express bias against any race, any religion, or any protected class of individuals, and
  - Opinions about any encounters with the public as a result of the member's job-related function
- D. Members should know that any postings or communications on social networking sites that communicate, perpetuate, or formalize their official actions or the official actions of another may be considered public record under Florida law.
- E. Members who are brought under administrative or internal investigation related to their performance, conduct, functionality or duties may be ordered to provide the agency, or its designated investigator, with access to the social media and/or social networking platforms in which they participate or maintain.
- F. On-duty use of personal social media and devices (cell phones, tablets, etc.) is allowed as long as it does not interfere with the course of the members' daily duties. If members do not adhere to this, they will be subject to disciplinary action.

### Deputy Sheriff Leach,

In accordance with references (a), (b), (c), and (d), you are hereby notified that I intend to impose a Written Reprimand Level II with 5-Day Suspension for cause due to your conduct outlined in reference (e). This decision is based upon the results of Administrative Investigation #2022-004 (e), the findings and conclusions of which I adopt. The basis for imposing this discipline is based on the following policy violation:

- 1) Violation of General Order 1000.2 II.G.2. Members shall be courteous, civil, and otherwise act with respect towards one another. They shall not publicly criticize any official act or member of the sheriff's office.
- 2) Violation of General Order 1000.2 III.B.3. Members shall not communicate information relating to proposed arrests or cases under investigation or to be investigated, except to the member assigned to the case, a supervisor, or unless authorized by a higher authority.
- 3) Violation of General Order 1000.2 III.F.10. Members shall not knowingly associate or fraternize with, correspond or communicate with, engage in criminal activity or accept services from or do favors for any detained, sentenced or pretrial inmate, or their family members charged to the custody of the Sheriff except as necessary to perform their duty functions as set forth by the rules and regulations.

4) Violation of General Order 1000.2 III.H. - Members shall avoid regular or continuous associations or dealings with persons who they know are under criminal investigation or prosecution, except as required by the performance of their duties, or where unavoidable, because of a personal relationship of the member. "Personal relationships" are defined as those relationships created by blood or marriage.

In accordance with reference (d), a member who has attained career status in the office of the Sheriff may only be disciplined for cause. It is my finding that your conduct as outlined above constitutes "cause" as defined in reference (d).

Prior to imposing this discipline, I will provide an opportunity for a pre-disciplinary hearing in accordance with reference (b and d). This hearing will be in my conference room on a date to be determined should you elect to have this hearing. This is your opportunity to present any evidence in dispute of the allegations, and to provide any mitigation prior to the imposition of discipline. If you elect to have this pre-disciplinary hearing, you must notify Internal Affairs in writing within two (2) business days of receiving this notice. If you do not make this notification, then you will waive your right to the pre-disciplinary hearing, and by the fourth (4) day after receiving this notice, the discipline outlined herein will be imposed.

In accordance with references (b), (c), and (d), you will be entitled to appeal any discipline imposed at this hearing that exceeds (5) five days unpaid suspension to the Career Service Appeals Board. Members who have attained career status may request a hearing by the Career Service Board within seven (7) working days.

Appeal Procedure - An appeal of action specified as appealable to the Career Service Appeals Board shall be made in writing to the Sheriff and hand delivered to the Sheriff or designee or sent via certified mail, return receipt requested.

The written appeal must be received by the Sheriff no later than seven (7) working days after the member is notified of the action on which the appeal is based. The written appeal will include the two (2) names selected by the member to serve on the Board. If the member does not comply with the time provisions of notifying the Sheriff in writing, it will be deemed that the member has waived their right to an appeal.

### Synopsis

Between November 18, 2021 and February 22, 2022, Deputy Sheriff Sherri Leach and Inmate Corey Binderim have communicated with one another via 23 separate telephone calls. All of the telephone calls were recorded by Securus Technologies; Clay County Jail Inmate Telephone System. During multiple telephone conversations, Deputy Sheriff Leach and Inmate Binderim discussed various details of Inmate Binderim's active criminal investigation and prosecution. Additionally, during one particular telephone conversation, Deputy Sheriff Leach criticized multiple members of the sheriff's office, specifically her immediate co-workers and supervisor.

### **Details of Investigation**

On February 11, 2022, Lieutenant A. Stacy, Detention Watch Commander, notified Sergeant K. Smith, Internal Affairs Supervisor, of the aforementioned communication between Deputy Sheriff Leach and Inmate Binderim. On February 14, 2022, Sergeant Smith notified me of the incident and instructed me to initiate this administrative investigation.

Unless otherwise noted, all of the following notifications, interviews, meetings, etc. were recorded in audio format. All of the recordings were downloaded to the IAPro digital case file. Additionally, all of the pertinent sworn testimony obtained was documented in this report via summary format. To obtain complete details, review the audio recordings in their entirety.

### Background Information:

Inmate Cory Binderim has been incarcerated in the Clay County Jail since March 3, 2020, when he was arrested for the offenses of Murder; Assault/Battery during Burglary; and Tampering with Evidence. Details regarding the aforementioned offenses are documented under CCSO Case #2020-027132 and State Attorney's Office (SAO) Case/Docket #2020-392CF.

Deputy Sheriff Leach has been employed by the CCSO since July 21, 2020. Deputy Sheriff Leach and Inmate Binderim previously established a unique lifelong pseudo-family relationship, which existed approximately 45 years prior to Inmate Binderim's arrest and incarceration on March 3, 2020.

On November 16, 2021, the Clay County Jail received a three-page typed letter from "Sherri Thompson" (Deputy Sheriff Leach) addressed to Inmate Binderim. On November 18, 2021, after viewing the letter, Inmate Binderim made his first telephone call to Deputy Sheriff Leach. Note: A copy of the letter was attached to this case file. Additionally, the content of the letter consisted of various life status updates regarding members of both Deputy Sheriff Leach's family and Inmate Binderim's family. There was not anything suspicious or anything out of the ordinary regarding the content of the letter.

### Review of Jail Telephone Calls:

On February 14, 2022, I gained access to the Clay County Jail Inmate Telephone System, Securus Technologies, and began my review of the recorded telephone conversations between Deputy Sheriff Leach and Inmate Binderim.

On February 22, 2022, I completed my review and confirmed the following results:

- There were a total of 23 completed telephone calls.
- The telephone calls occurred between November 18, 2021 and February 22, 2022.

All of the telephone calls were made by Inmate Binderim to Deputy Sheriff Leach's personal cellular telephone;

### Principal Notification: Deputy Sheriff Leach

On February 23, 2022, I met with Deputy Sheriff Leach at the Internal Affairs Office. Deputy Sheriff Leach was presented with the following documents: Member Notification of Internal Affairs Investigation; Administrative Rights; Notification of Florida Police Bill of Rights; Garrity Warning; and Perjury Warning. Subsequent to her review, Deputy Leach confirmed she fully understood the content of all the documents. After providing her with a copy of the aforementioned documents, and explaining the administrative investigation process, the meeting was concluded. Prior to concluding the meeting, Deputy Sheriff Leach agreed to return to the Internal Affairs office the following day to conduct her evidence review.

# Principal Evidence Review: Deputy Sheriff Leach

On February 24, 2022, I met with Deputy Sheriff Leach at the Internal Affairs Office. Deputy Sheriff Leach was presented with a compact disc. The disc contained General Order 1000.2, Inmate Binderim's jail correspondence (letters), and (23) recorded telephone calls. Deputy Sheriff Leach conducted her evidence review inside the interview room using an agency issued desktop computer. Subsequent to the completion of her review, I asked Deputy Sheriff Leach if she had any questions regarding any of the information she reviewed. Deputy Sheriff Leach stated she did not. I then asked Deputy Sheriff Leach when she wanted to schedule her interview. Deputy Sheriff Leach requested to schedule her interview on Wednesday, March 9, when she returned from an out of town training class. After confirming the date and time of the interview, the meeting was concluded.

## Principal Interview: Deputy Sheriff Leach

On March 9, 2022, I met with Deputy Sheriff Leach and Fraternal Order of Police (FOP) representative J. J. Dixon at the Internal Affairs Office. Deputy Sheriff Leach was presented with the following documents: Member Notification of Internal Affairs Investigation; Administrative Rights; Notification of Florida Police Bill of Rights; Garrity Warning; and Perjury Warning. All of the aforementioned documents were previously reviewed by Deputy Sheriff Leach on February 23. Subsequent to her additional review, Deputy Sheriff Leach confirmed she fully understood the content of all the documents. I then asked Deputy Sheriff Leach if she was prepared for her interview. Deputy Sheriff Leach confirmed she was prepared and wanted to proceed with the interview. Deputy Sheriff Leach provided the following sworn testimony.

When asked to explain her relationship with Corey Binderim, Deputy Sheriff Leach stated, "My entire life I have been told that Corey Binderim is my brother. We were raised with two sets of parents and four of us kids as a family unit. We shared homes a lot of the same times. My dad and Corey's dad were in the military. We were transferred to a lot of the same duty stations."; "It's obvious that there is a very deep significant bond, that of siblings between myself and Corey. The dictionary definition of family; I went to look at it because it's being questioned as to whether or not we are family. And as far as anybody in either of our families are concerned, and if you were to ask any of them, they will tell you

that we are in fact family."; "Now I do understand what has been brought to my attention as these sheriff's office policies stating personal, that you cannot communicate with an inmate unless it's personal relationships. To me, there's no question that this falls under a personal relationship."

Subsequently, Deputy Sheriff Leach stated she believed there was a possibility that she and Corey Binderim were related by blood. Deputy Sheriff Leach referred to the genealogy company of "Ancestry.com" and explained because she was related to several thousand people; it was possible Corey Binderim was one of those people. When asked if she possessed any knowledge regarding the possibility she was related to Corey Binderim by blood or marriage, Deputy Sheriff Leach stated, "I will say this, so our familiar relationship started approximately 1976. I was born in 1974. Corey was born in 1975. We do not know life without each other. Our families do not know, I have no recollection of existing in this life without the Binderim's being part of my family. There were numerous times when we transferred duty stations together, where we would move and then they would move behind us and we would share a home. In fact, when we moved to Fleming Island, they moved here from Italy. We shared a home until they built there house around the corner from us."

I subsequently interrupted Deputy Sheriff Leach and asked prior to explaining her extensive history with the Binderim family, did she possess any proof that she was related to Corey Binderim by blood or related to Corey Binderim, and emphasized she did not possess any proof whether she was or was not was the same possibility that she and I could be related, Deputy Leach stated, "Absolutely!" After expressing her interpretation of the policy definition regarding personal relationships, Deputy Sheriff Leach stated, "When I read personal relationships, there is no question whatsoever that this is my family."; "I feel like, by definition of personal relationships, that this one hundred percent qualifies for that. And it's a matter of opinion whether it does or does not. To me it was never a question. I would never intentionally violate any policy."; "Violating a policy intentionally, that's not Sherri Leach. I think everybody that knows me will attest to that. When I read this and it said personal relationships, I felt like, that's us. This covers us."

Deputy Sheriff Leach continued to provide extensive and detailed information regarding her lifelong relationship with the Binderim family, which she described as a "rare", "nontraditional"; and "unique family unit." Note: Deputy Sheriff Leach provided 12 pages of documents regarding various digital and social media interactions with the Binderim family. Included in the documents was Deputy Sheriff Leach's CCSO Employee Basic Information Sheet, which was completed in July 2020, and listed "Eric & Stacy Binderim" as her "Bonus Parents" under the Emergency Information section. Additionally, Deputy Sheriff Leach stated her unique relationship with the Binderim family was defined by various legal documents such as wills and power of attorney. All of the aforementioned documents provided by Deputy Sheriff Leach were attached to the case file. Deputy Sheriff Leach added, "I feel like all of that was proof to back up what I'm saying. That this is not just some friend. This is holidays, vacations. We spent every single weekend together. We made trips across the country together."; "We shared tents. We shared pop up campers. We shared homes. We shared pets." Referring to the Binderim family, Deputy Sheriff Leach stated, "They are our family." Deputy Sheriff Leach added, "It's not my desire to make the sheriff's office look bad or make anybody angry. That's not my intention. This is my brother and I feel like I needed to let him know that I love him and that he's not alone in the world.",

"I sit in church every week and they tell you it's not the righteous that need Jesus, it's the sinners. How do I just turn my back on somebody that I love?", "It's painful for me. All I can do is love him and pray for him, and hope that I can help lead him to salvation. Because, whatever happens with this, I mean there's a good chance from what I hear from his wife that he is looking at the death penalty. If that's the case, what kind of person am I to just say okay, see ya.", "My job is to make sure he is saved."

When asked to describe how she initiated contact with Corey Binderim, Deputy Sherriff Leach stated she initially contacted him in February 2021 via the previous Chaplain, Douglas Matyi. Deputy Sheriff Leach explained Corey Binderim's father had just passed away and she asked Chaplain Matyi to personally make the death notification to Corey. Deputy Sheriff Leach stated her actions were solely to inform Corey of his father's passing, and there was not any other message or information communicated to Corey during that process. Subsequently, Deputy Sheriff Leach referred to the policy prohibiting her communication with Inmate Binderim and stated it was not fair. After explaining there were exceptions to rules under specific circumstances and with the appropriate supervisor notification and approval, I asked Deputy Sheriff Leach if she spoke with any supervisor, explained the unique circumstances, and requested approval to communicate with Corey Binderim. Deputy Sheriff Leach replied, "I did not. Because I felt like I was covered under the personal relationships completely."

After referring to personal relationships within the sheriff's office, Deputy Sheriff Leach stated she wanted "to clear the air" regarding a comment she made during one of her conversations with Corey Binderim, specifically their conversation on February 11, 2022 @ 3:43:02 p.m. During the conversation, Corey stated she (Deputy Sheriff Leach) probably did not want to mention their connection/relationship to the sheriff. Subsequently, Deputy Sheriff Leach replied,

Describing what she meant by that comment, Deputy Sheriff Leach stated she was referring to a personal conversation with she had with Michelle Cook prior to her becoming sheriff and prior to her (Deputy Sheriff Leach) becoming a deputy sheriff. Deputy Sheriff Leach added the conversation took place during the time when Corey Binderim was identified as a person of interest in the case. During the conversation, "Sherri Leach" simply mentioned to "Michelle Cook" that Corey Binderim was her brother and she was devastated that Corey was even involved in the incident. Deputy Sheriff Leach emphasized that after she made the comment, the matter was not discussed any further. After explaining her comment had raised speculation that Sheriff Cook was possibly aware of her communication with Corey Binderim, I asked Deputy Sheriff Leach if Sheriff Cook had any knowledge regarding her communication with Corey Binderim since he was arrested and incarcerated in the Clay County Jail. Deputy Sheriff Leach replied, "Absolutely not. Absolutely not. Nobody, nobody knows."

The interview then transitioned to discuss the letter Deputy Sheriff Leach sent to Corey Binderim at the Clay County Jail. Deputy Leach stated, "The reason why I sent the letter as Sherri Thompson was twofold; one, it's because Corey knows me as Sherri Thompson."; "The other reason was because I didn't want somebody that was reviewing mail in the jail to pull it and come to some conclusion or say, well, hold on, what is this? Blah, blah, blah, blah. So I was like, well, let's don't open that can of worms where people are asking questions or somebody's going hold on, you know, why is she sending, because I don't feel like that was something that should have been discussed at the level of whoever's reviewing the mail."; "And the other reason, the flip side of that is he's in with inmates that I don't want

them, he doesn't want them to know who I am and the job that I hold."; "I felt like it made sense for both sides."

After reiterating her thought process and concern regarding the use of Sherri Thompson for the aforementioned letter, I asked Deputy Sherriff Leach if she had any concerns having over 20 recorded telephone conversations with Corey Binderim? Deputy Sheriff Leach stated, "I don't feel like I have anything to hide. I don't have anything to hide."; "I am the most transparent, honest person that I know. I have nothing to hide. Every action that I have done, purely comes from the heart. I have not done anything that I felt like oh, what did I do."; "My intentions are pure. I wasn't trying to hide anything."; "I didn't intentionally do anything wrong here."

The interview then transitioned to discuss the previously identified nine pertinent telephone calls.

Call #1: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach did not provide any additional information.

Call #2: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach did not provide any additional information.

Call #3: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach stated she did not acknowledge Corey's rant nor any of his disparaging comments. Note: Deputy Sheriff Leach and I discussed that there was not a policy which required her to prevent Corey Binderim from speaking disparagingly of agency members but it was reasonable and prudent for her to attempt to prevent Corey Binderim from doing so.

Call #4: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach did not provide any additional information. Note: Deputy Sheriff Leach previously explained her reasons why she addressed the letter she sent to Corey Binderim using the name Sherri Thompson.

Call #5: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach stated she is familiar with Corey Binderim's criminal history, which she emphasized consisted of only one criminal offense that occurred when Corey was a juvenile. Deputy Sheriff Leach added since that time and until his recent arrest and incarceration, Corey has been a law-abiding citizen and a devoted family man for many years, decades.

Call #6: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach did not provide any additional information.

Call #7: After explaining the pertinent aspects of the call, and confirming its content, Deputy Sheriff Leach stated, "I have absolutely no ill will whatsoever to any of my co-workers." Regarding her comments about her co-workers getting "black eyes", Deputy Sheriff Leach stated, "Should I have said that? No. Should I have told him on a recorded line that I have new beat partners that hate my guts and they're not nice to me? No, of course not. I shouldn't have said it. I should not have shared that information with him. In hindsight, I would have never discussed anything about my work whatsoever

with him on a recoded line."; "I take responsibility for that."; "He asked how my day was and I spilled my guts, and I shouldn't have."

Call #8 and Call #9: After explaining the pertinent aspects of the calls, and confirming there content, Deputy Sheriff Leach stated she did not recall asking Corey any specific questions regarding his case, and her responses to his comments were general in nature just to indicate she acknowledged what he was saying. Deputy Sheriff Leach added, "Should I have stopped him immediately when he starting talking about his case? Absolutely. I don't deny that." Note: Deputy Sheriff Leach voiced her confusion regarding the allegation she engaged in discussion with Corey about his case. I explained to Deputy Sheriff Leach though her discussion with Corey about his case was general in nature, general curiosity, it was a discussion of his case nonetheless. Additional Note: Regarding her discussion about Sheriff Cook, Deputy Sheriff Leach previously explained and clarified the comment she made regarding Sheriff Cook. When asked if she felt it was appropriate to discuss Sheriff Cook in the manner described on the telephone call, Deputy Sheriff Leach replied, "No, of course not."; "That falls under discussing my work."; "It should have never been discussed."

Toward the end of the interview, I asked Deputy Sheriff Leach if she wanted to add anything to her statement. Deputy Sheriff Leach replied, "I feel like the biggest question here is, goes back to the personal relationships." Deputy Sheriff Leach then reviewed and summarized the importance of each document she provided as evidence to prove her unique relationship with Corey Binderim and the entire Binderim family. Deputy Sheriff Leach added, "We're supposed to selflessly serve with honor and courage. I don't feel like excluding people's family members because they have somebody incarcerated. I think it kind of goes against what our goal is here."; "I love this community. I don't do this job just to do this job. It's because I want to be in the community. I want to, everybody says, well I want to make a difference. No, that truly is, that's truly why I'm here."

Deputy Sheriff Leach added, "Since the day I was called in to report here, I have not spoken to anyone about this investigation. However, the rumor mill has drug my name through the mud. My integrity has been questioned. Lifesaving training that could save the life of my children's mother was cancelled. I was not permitted to attend any event at the Elks Lodge that I have been long involved with in attending for many years prior to my employment at CCSO. I have not been able to speak to my brother. I have not been able to explain to him why I can't take his phone calls, which every time the phone rings and it's him, it really puts me through an emotional turmoil because I don't feel like that's fair. I think if this is the decision that I am not allowed to speak with him, that he needs to be told why and what's going on. It's not fair to him and it's not fair to me that he continues to call and I'm not allowed to talk to him. I have not spoken to my bonus mother, Corey Binderim's biological mother, because now I am afraid because of what the policy says. I'm afraid to go help her fix her fence. I'm afraid to go let her dogs out for her. But I can help the widow around the corner from her because I haven't asked him, does he have a family member in the jail. I just feel like we need to look at this policy and refigure out if this is really the message that we want to convey and really what we want to do as far as helping our community members. I have not been able to explain or answer questions to my family about the situation. It really has taken an emotional toll on me and my children and my parents. I feel like I have already been punished severely. My actions came from a place of nothing but love and my desire to follow God's heart. It was never my intention to violate any policies or place the sheriff's office in a

position to question my conduct, which is merely a lot of opinion based. However, I will tell you that I stand on a solid foundation of truth. My integrity is intact and my motives stem only from the heart. At no time did I ever question my relationship with Corey as being non-family. I never thought that anybody would question our relationship as being non-family. I believe that I have more than established my proof and my familiar relationship with Corey Binderim. And I would like to when this is over resume contact with my family. I would in no way, shape, or form allow him to comment on his case, other sheriff's office members, or even converse about my job. But I do feel like our policy needs to be updated to include adopted children. Our sheriff's office members who are raising children that are involved in gay and lesbian relationships, and we do have those. And this is brought to my attention and it's made me think about them. What if their child, who they have raised since they were a small child, but they have not, they don't, legally they're not blood or marriage; is in a situation they're not going to be able to converse that child, and I don't think that's fair. It needs to be updated to include non-traditional family units, same household units, and foster children. I have served my community with gratitude, empathy, love, and pride. And it's incomprehensible to me that I would have to chose to give up my own family to continue serving the community that I truly love." Subsequently, the interview concluded.

## Follow Up Principle Interview: Deputy Sheriff Leach

Immediately following the conclusion of the initial interview, Deputy Sheriff Leach requested to provide additional information that she believed was pertinent. Subsequently, I reactivated my digital voice recorder and documented the following additional sworn testimony provided by Deputy Sheriff Leach.

Deputy Sheriff Leach stated she wanted to provide additional information regarding the reasons why she decided to write and send Corey Binderim a letter at the Clay County Jail. Deputy Sheriff Leach stated she worked on the letter for a long period of time, "and it was weighing heavily on my heart." Deputy Sheriff Leach explained that in two short years, two of her family members passed away and one was incarcerated. Deputy Sheriff Leach stated, "I just felt like I needed to reach out to Corey and let him know that he is loved and, I mean, he's my family. And so, it just weighed on me and I wanted to talk to him about his salvation."; "The fact that he's possibly facing the death penalty is very concerning to me as a Christian."; "I felt that it was important to reach out to him and let him know that heart." After explaining Corey Binderim had lost his father and sister in two short years, Deputy Sheriff send the letter. Not just for me, but for him, but also for his mom, and for my parents. So I can hey, I reassure them."

Deputy Sheriff Leach added, "I didn't ask him to call me in the letter. But he did. And when he did,", "I never thought that anything, about anything being wrong with him calling me or me sending a letter to him." Deputy Sheriff Leach reiterated her concern and responsibility regarding Corey Binderim's salvation. Subsequently, the interview concluded.

## **Investigation Conclusion**

Investigation concluded that the allegations made against Deputy Sheriff Leach pertain to violations of the following Clay County Sheriff's Office directives.

## General Order - 1000.2 (Code of Conduct)

- II. Obligations to Demonstrate Courtesy and Cooperation
  - G. Courtesy to and support of co-workers.
    - 2. Members shall be courteous, civil, and otherwise act with respect towards one another. They shall not publicly criticize any official act or member of the sheriff's office.
- III. Constraints on Behavior
  - B. Information
    - 3. Members shall not communicate information relating to proposed arrests or cases under investigation or to be investigated, except to the member assigned to the case, a supervisor, or unless authorized by a higher authority.
  - F. Abuse of position or authority:
    - 10. Members shall not knowingly associate or fraternize with, correspond or communicate with, engage in criminal activity or accept services from or do favors for any detained, sentenced or pretrial inmate, or their family members charged to the custody of the Sheriff except as necessary to perform their duty functions as set forth by the rules and regulations.

Exception: Members assigned or conducting an investigation authorized by their chain of command.

- III. Constraints on Behavior
  - **H.** Members shall avoid regular or continuous associations or dealings with persons who they know are under criminal investigation or prosecution, except as required by the performance of their duties, or where unavoidable, because of a personal relationship of the member. "Personal relationships" are defined as those relationships created by blood or marriage.

# **Disposition Recommendations**

Allegation #1: Deputy Sheriff Leach publicly criticized members of the sheriff's office.

**Pertinent facts/evidence:** Deputy Sheriff Leach's criticism of her co-workers and supervisor was recorded by the CCSO jail inmate telephone system.

Recommendation: Sustained

Allegation #2: Deputy Sheriff Leach communicated information relating to a criminal case under investigation.

**Pertinent facts/evidence:** Deputy Sheriff Leach's discussion of Inmate Binderim's active investigation and prosecution was recorded by the CCSO jail inmate telephone system.

Recommendation: Sustained

Allegation #3: Deputy Sheriff Leach knowingly associated and communicated with a pretrial inmate, specifically Inmate Corey Binderim.

Pertinent facts/evidence: Deputy Sheriff Leach's association and communication with Inmate Binderim was confirmed via one letter and the 23 recorded telephone call conversations with Inmate Binderim.

Recommendation: Sustained

Allegation #4: Deputy Sheriff Leach regularly and continually associated with a person known to be under criminal investigation and prosecution, specifically Inmate Corey Binderim.

Note: The current policy definition of the "personal relationship" exception does not apply.

**Pertinent facts/evidence:** Deputy Sheriff Leach's regular and continuous association with Inmate Binderim consisted of one letter and 23 recorded telephone calls from November 18, 2021 to February 22, 2022.

Recommendation: Sustained

## **Policy Change Recommendation**

**Background:** Regarding agency member association/communication with incarcerated persons and/or persons under criminal investigation, the current policy provides an exception, specifically a "personal relationship", which recognizes relationships created by blood or marriage. However, the current policy does not address other types of unique relationships, which could reasonably fall under the purview of personal relationships.

**Recommendation:** It is recommended the applicable policy be amended to include an expanded definition of personal relationships. Additionally, it is recommended the applicable policy be amended to include verbiage that requires agency members to obtain the appropriate supervisor approval prior to engaging in any such association/communication.

I have reviewed this Internal Affairs Investigation as requested by Sergeant Smith. I concur with his and Detective Matos' recommendation of a **sustained** finding in all allegations. My recommendation is that Deputy Leach receive not less than a 30-day suspension without pay and a Level 2 Written Reprimand. I reviewed the Disciplinary Action Guide and concluded this based upon the following factors:

- 1. Deputy Leach repeatedly states she did nothing wrong and had nothing to hide, yet she concealed her identity initially and admitted to deciding not to consult a supervisor or higher authority about having contact with Bindarim. Moreover, Deputy Leach stated several times during her interview it was no one else's business what she was doing. Given her knowledge of Bindarim's current murder indictment and his criminal history including a previous conviction for attempted murder at age 18, the point-of-view she displays confirms a total disregard for the code-of-conduct policy. It also confirms she is unconcerned with the "big picture," and why there must be constraints on CCSO member's behavior, personal or professional.
- 2. Whether Deputy Leach and Bindarim are, or are not family members, is relevant only to the fourth policy violation. The others deal with the content of the communications between them. The content of their communication is not about salvation for Bindarim as she stated repeatedly in defense of her actions. It is instead talk between longtime, close friends about several inappropriate topics, including Bindarim's murder indictment and confidential information on-workers.
- 3. Deputy Leach accepted no responsibility for the decisions she made. She splits hairs on policy and meanings of words like "family member," while simultaneously asking the Agency to take a broad interpretation of policy. She suggests her situation with Corey Bindarim should be an exception to the policy but she only suggests this once caught and questioned, instead of seeking guidance or permission beforehand. While I know from the previous investigation on Bindarim he is a master manipulator, I would expect Deputy Leach to know this as well given

their long association. I do not see how she could fail to see the conflict of interest in giving him <u>any</u> information about CCSO or any of its members. I therefore conclude she knew she was in the wrong from the beginning, but still moved forward with her plan hoping no one would notice.

4. Although egregious, these violations can be a learning moment if Deputy Leach is ultimately able to acknowledge her errors in judgment. My knowledge of her work product otherwise is that she is a reliable deputy and her supervisors have not reported any other discipline or performance issues. Since Deputy Leach has violated numerous policies and, thus far avoided responsibility for it, I suggest discipline in-line with similar code-of-conduct violations in order to correct her judgement moving forward.

After his Mom passed away, he said he was done drinking and that he was getting his life together, that lasted about 3 weeks. I worry about him, he is literally drinking himself to the grave. I see so many people everyday that have given their lives to alcohol, it's horribly sad.

Life is hard, you know. What I wouldn't do to trade today's stressors for a good old fashioned violent game of spoons. 
i ran across some pictures the other day of our trip to New Orleans and from the 80's party, Chad's wedding, etc. I just remember we all just had no real cares in the world. How does that change to what our new reality is now? Surely that can be the best times of our lives and it's all downhill from there. Don't get me wrong, I am happy and content for the most part, but dang, life has dealt us some doozies, hasn't it? I am still so incredibly crushed over losing Rosie. Like how did that even happen? I have a tattoo in her honor on my left arm, the rose is the center and it's surrounded by wildflowers. I get asked about it a lot and I always take that opportunity to share Rosie's story with them. I pray that it makes a difference for someone. I ran in to Tony Mack, her ex, recently, he looks like a crack head. Ugh.

I don't know how you are dealing. If they offer to allow you to talk to someone, a counselor, the pastor, anyone, take them up on it. We were taught to just man up and deal with whatever is thrown our way. I think that's the old salt navy way of doing things. But, that's just not reality. We can only take so much. I have learned that it helps me to talk through it. You and I both have had a lot of heartache in the last few years, none of which is easy to swallow. I want you to be ok so ask for help if you need it. I don't know the new chaplain there, but if he was chosen for the position, I am sure he is a good dude.

I have been attending Church on Thursday nights in Fleming at Eleven22, best decision ever. You know years ago, I attended on a regular basis, but wouldn't go with me and the kids and I got frustrated with him and ultimately quit attending. I am back at it and I feel SO much better. It's like a weekly dose of joy. I keep a Bible in my car at work too and if I need a moment, I flip to a random page and read a passage. It's a history book, but it's full of wisdom. I always land on a page that gives me the clarification and caim that I need.

No matter what happens in our lives, you will always have my prayers and love. You have been the closest person to me for my entire life. Even though we had periods of going our own ways. You have always been a constant for me. I think of all the times you and Chad Williams rescued me or pep
