What your License is suitable for:

Local TV, Radio, Online video, Apps promoting a product, service or brands such as corporate video, charity films, and tutorials for business websites.

What your License is suitable for:

Use of music in a single film or video distributed online, or for submission to film festivals.
Not to be used for broadcast on Television or promoting a product, brand or service.

Non-Profit

What your License is suitable for:

Use for creating a film or slideshow for a non-profit organization. Content may include company highlights, event coverage, cultural highlights, and employee insights - films that give an overall sense of the spirit of the organization. A company is a Non-Profit only when registered with the government as an eligible and official Non-Profit Organization. In the U.S.A., for example, a Non-Profit is designated by the IRS as a 501(c). Not to be used for fundraising campaigns or any film or slideshow showing a specific product used for profit.
