Overview

Media For All ("we", "us", "our") is committed to protecting your privacy. This Privacy Policy explains what personal information we collect, how we use it, and whether and how opt-in information is shared.

### 1. Information we collect

We collect the following types of personal information when you interact with our website or services:

- Contact & identity data: name, email address, phone number, mailing address.
- Account & payment data: username, password, billing information, invoices (collected only if you register or purchase).
- Usage & device data: IP address, browser type/version, device type, pages visited, session duration, referring URLs, and cookies.

- Marketing preferences / opt-in choices: whether you choose to receive newsletters, promotional emails, or other marketing communications.
- 2. How we use collected information

We use your information for these purposes:

- Provide & manage services: to create and manage your account, process payments, deliver purchased services, and communicate about orders or bookings.
- Customer support: respond to inquiries, troubleshoot issues, and provide assistance.
- Improve our services: analyze usage to improve site features, content, and user experience.
- Security & legal: detect and prevent fraud, enforce our Terms, and comply with legal obligations.
- Marketing (with consent): send newsletters, promotions, and event notices if you've opted in. You may withdraw consent at any time (see "Your choices" below).
- 3. Sharing of opt-in / marketing information
- We do not sell your personal information.
- Third-party service providers: If you opt in to receive marketing or other communications, we may share your name and email (or other necessary contact details) with trusted third-party service providers who send communications on our behalf (e.g., email platform, CRM). These providers are contractually required to protect your data and only use it to deliver the services we hire them for.
- Partners & sponsors: We will only share your opt-in marketing preferences with partners or sponsors if you explicitly consent to that sharing. We will clearly request that consent before sharing.
- Legal requirements: We may disclose information to comply with laws, court orders, or protect rights, property, or safety.

## 5. Data retention & security
