

TERMS & CONDITIONS

THE ULTIMATE RIDER

Effective Date: January 3, 2026

1. DEFINITIONS

The Ultimate Rider refers to Ultimate Rider Production. User refers to any website visitor. Applicant refers to any individual submitting an application. Participant refers to any rider selected for evaluation, production, or competition.

2. WEBSITE USE

Users agree to use the website only for lawful purposes. Unauthorized access, misuse, interference with site functionality, or reproduction of site content without permission is prohibited. Access may be restricted or terminated at any time.

3. APPLICATIONS & ELIGIBILITY

Applications are open to riders age 16 and up. Applicants under 18 must provide verified parental or legal guardian consent. Submission of an application does not guarantee selection or participation. All application decisions are made at the sole discretion of Ultimate Rider Production.

4. FEES & PAYMENTS

A non-refundable processing and evaluation fee of \$500 per applicant is required. Applications are not considered complete until payment is received. Fees are non-refundable regardless of outcome, withdrawal, or disqualification. Payments are processed through secure third-party providers.

5. RIDER EVALUATION & SELECTION

Applicants may be scheduled for rider evaluation days. Dates, locations, and formats are determined by production. Attendance and compliance are mandatory. All selection decisions are final.

6. FILMING, MEDIA & CONTENT RIGHTS

Applicants and participants acknowledge they may be filmed or recorded and grant Ultimate Rider the right to use their name, image, likeness, voice, and performance worldwide for media and promotional purposes. No compensation is guaranteed unless expressly stated.

7. CONDUCT & COMPLIANCE

Participants must act professionally. Prohibited behavior includes unsportsmanlike conduct, substance abuse, aggression, cheating, refusal to follow instructions, or violation of housing or isolation rules. Violations may result in immediate removal without compensation.

8. ASSUMPTION OF RISK

Motocross activities are inherently dangerous. Participants accept all risks, including serious injury or death, and agree to hold Ultimate Rider Production harmless to the fullest extent permitted by law.

9. MEDICAL & SAFETY

Participants must disclose relevant medical conditions. Medical staff decisions are final. Injuries must be reported immediately. Failure to disclose information may result in removal.

10. INTELLECTUAL PROPERTY

All website content, logos, branding, and materials are the exclusive property of Ultimate Rider Production. Unauthorized use is prohibited.

11. TERMINATION

Ultimate Rider Production reserves the right to reject applications, remove participants, terminate website access, or modify or cancel events at any time without obligation.

12. LIMITATION OF LIABILITY

To the maximum extent permitted by law, Ultimate Rider Production is not liable for indirect damages, loss of opportunity, injuries, accidents, or service interruptions.

13. GOVERNING LAW

These Terms are governed by the laws of the State of California. Any disputes shall be resolved in the appropriate courts within California.

Terms may be updated at any time. Continued use of the website constitutes acceptance of revised Terms.
