

RULES AND REGULATIONS**

The following rules pertain to owners and guests of Sundial. We ask that you adhere to all these rules and regulations so that Sundial may be enjoyable for everyone.

1. Nothing shall be placed in the walkway, stairways or elevators to cause an obstruction. Nothing shall be hung from doors, windows, balconies or corridors and no bicycles; skateboard riding, rollerblading/skating, or the like, shall be done on walkways of the buildings.
2. No cooking or grilling of any nature shall be permitted on the porches, lawns, or any exterior part of the buildings. No personal grills of any kind are allowed at Sundial.
3. Games or other sporting activities are prohibited in the courtyards. Moped or motorcycle riding except for ingress and egress is only permitted on the driveway areas.
4. Only owners are permitted to have pets in their units. However, owners must curb, leash, and maintain proper control over their pet at all times when not in their unit. Pets are prohibited from being walked on the common elements except for ingress and egress to their apartment. Guests are not permitted to have pets.
5. All garbage and refuse are to be deposited only in the receptacles provided in each building.
6. Automobile parking spaces shall be used solely and exclusively for that purpose. They shall not be used for the storage of boats, inoperative vehicles, or any purpose whatsoever other than parking facilities aforesaid. There are no assigned parking spaces. All parking spaces are available on a first come, first serve basis unless a reserved sign has been posted by the unit owner. Parking permits must be displayed while on the property. Any vehicle too large to fit in a parking space may not be parked on the association property.

7. No apartment owner or resident shall play or permit to be played any electronic devices (stereo, television, etc.) or other loudspeakers, or speak in a loud manner in any unit between the hours of 11:00 PM and 8:00 AM if the same shall disturb or annoy the other occupants of the buildings.
8. Owners, residents, their families, guests, servants, employees, agents, and visitors shall not be at any time or for any reason whatsoever enter upon or attempt to enter upon the roof or power rooms of any building.
9. All apartment doors are to be closed at all times, except when in use for the purpose of ingress and egress.
10. There shall not be kept in any unit any flammable, combustible or explosive fluid, material or chemical or substance, except for regular household use.
11. No apartment owner or resident shall direct, supervise or in any manner attempt to assert any control over any of the employees of the association, nor shall he/she attempt to send any such employees upon private business.
12. Please deposit all trash in receptacles located on each floor near the elevators and washrooms. Waste is removed from the containers daily.
13. Quiet hours must be observed from 10:00 pm to 8:00 am
14. The Sundial pool is located between the A and E buildings and is open from 8:00 am to dusk. No glassware or food is permitted in the pool for safety. Furniture may not be removed from the pool deck. Additional safety rules are posted at the pool.
