West Ky Labs extends the following warranties, guarantees only to the buyer below: We guarantee all papers on stated registered puppies. We guarantee all puppies to have had all treatments and vaccinations as stated on written health record. We make no guarantees of your puppy's mature size, or that it will be show, or breeding quality. We warrant against life threatening genetic defects for the first 1 year. You must request a written statement from your vet on office stationary and signed by him\her for our records, stating health problem to include a description of the symptoms supporting his or her opinion to validate guarantee. If you suspect that your puppy has a genetic defect you must take your puppy to a licensed veterinarian within the first year of delivery. You must notify us the day of initial examination to make claim for a replacement puppy. The original puppy must be returned (alive) within 24 hours along with all paperwork. If you choose Euthanasia without our prior consent you will forfeit any guarantees within this contract. You agree to fill out all necessary forms to return ownership of puppy to breeder. If you qualify for a replacement puppy, we will provide a new puppy of equal value, if one is available, or from next available litter (WITHIN 1 YEAR OF ORIGINAL DATE OF PURCHASE). If you choose a puppy of greater value you are responsible to pay the difference. Buyer is responsible for all shipping or transportation fees.

This guarantee does not cover: Hernias, Weight, Breeding ability or any other standards of this puppy. This puppy is sold as pet quality only. Seller is not responsible for immunity level, mites, pneumonia, mange, heatstroke, ringworm, conjunctivitis, fleas, ticks, and ear infections once puppy has left Sellers hands. Buyer is responsible for keeping their puppy away from contaminated areas, out of the heat and cold drafty places. Guarantee is not valid if sold to a third party. The Seller is not responsible for any Veterinarian bills the Buyer may incur regarding said puppy. Buyer is responsible for making sure they continue their new pets vaccinations and worming. Buyer is responsible for providing their new pet a healthy diet, proper exercise, and a loving environment.

Since weaning, your puppy has been fed TLC Whole Life Dog Food; formulated to meet AAFCO's nutrient profiles for growth and maintenance. TLC uses high-quality meat-based protein sources, fresh fruits, and veggies and offers complete and balanced nutrition, essential for growing puppies. TLC can be purchased through their website at telepetfood.com and is delivered free to your doorstep. Based on our experience with a wide variety of food, we strongly recommend the Buyer continue feeding their puppy TLC Pet Food. Providing a quality diet is critical to the puppy's overall health and well-being and as such; we will extend this guarantee for an additional year if the puppy continues to be fed TLC after leaving our care. We also send all puppies home with a starter kit of Nuvet Vitamins and information on how to order more vitamins. We STRONGLY recommend that the Buyer continue to give their puppy Nuvet Plus to ensure proper nutrition and provide a full spectrum immune system builder. Due to the varying kinds of food and different environmental conditions the puppies come in contact with, we will not guarantee their health unless they are given NuVet Plus® for 2 years using NuVet Labs' recommended dosage. Failure to do so makes the guarantee null and void.

West Ky Labs guarantees our puppies hips for a period 2 years from the puppies birth. If dysplasia is suspected, x-rays must be taken by a veterinarian and sent to the OFA for an official reading with abnormal results (mild, moderate. or severe). Breeder does not cover any form of dysplasia that is not genetic (obesity, malnutrition, neglect, etc.) to ensure this is not the case, puppy must be kept current on all regular vet check- ups and vaccinations. Puppies will be sent home with a current vet record of vaccines given and will be vet checked in good health before being released to the buyer. Puppy cannot be bred prior to their 2nd birthday or this guarantee is null and void. If a problem arises and all documentation has been received, the buyer will then be entitled to a replacement puppy of the same sex and color in the next available litter (WITHIN 1 YEAR OF ORIGINAL DATE OF PURCHASE). This guarantee does not transfer. This guarantee is for a replacement puppy ONLY and holds no cash value. Buyer is responsible for all shipping expenses for replacement puppy and will also keep the original dog purchased.

DITATEDIC NAME.

By signing this contract you are agreeing that it is your responsibility to place this puppy in a new, appropriate home, regardless of financial compensation if:

This is the primary reason your puppy may not come back into our environment, the risk of exposing our babies that are here to outside Contaminants and diseases is too high.

We are NOT responsible for vet fees, treatment costs, transportation costs, stress, or other expenses. All sales are final and irreversible with the only exceptions being those as stated above.

To summarize, I understand that if I choose not to purchase Nuvet Vitamins & keep my puppy/dog on them for 2 years of their life I have no guarantee at all for my puppy/dog. I understand that if I purchase/keep my puppy/dog on TLC Whole Life food and Nuvet vitamins (for the first 3 years of his/her life) that I will add an extra year to my guarantee for my puppy/dog. This guarantee will then cover genetic defects for the first two years & hip dysplasia for first three years.
