### **REGISTRATION FEES, TERMS & CONDITIONS**

Artists must complete their registration form and payment (PayPal or Credit Card). *Note that a good-quality image, without the frame, must be uploaded with the registration for each entry.* 

A non-refundable fee of \$15.00 per member will be collected with your online application. An artist may enter up to 3 images. The WAOTC Exhibition Committee will select from the entries and will try to include as many pieces as possible while maintaining a cohesive and professional-looking exhibit. WAOTC cannot guarantee that every applicant (or every submitted piece) will be represented at this show.

For this show only, WAOTC will not take a commission on sales. Sales will be transacted between the buyer and the seller. Artists must provide contact information for the wall tags (QR code for payment, phone number or email address).

Although utmost care will be taken when handling the artwork, this does not eliminate the risk of damage. Neither WAOTC, Inc. nor Berkshire Hathaway Home Services Carolina Premier Properties will be held liable for damaged or lost artwork. Artists are encouraged to obtain an art insurance policy for their artwork.

WAOTC, Inc. reserves the right to use the images of selected work for publicity purposes only. Any other uses are strictly prohibited.

Exhibition space is limited to wall space only; therefore, only 2D art will be accepted:

- Artwork must not exceed 24" on either side or 15 lbs total weight.
- Mediums can include any painting medium, photography, works on paper, canvas or panel, 2D mixed media and 2D fiber art (as long as it can hang properly on a wall)
- Must be ready and professionally presented at check-in: framed or gallery-wrapped canvas/panel (1" minimum depth) with painted sides (either continuing image or a solid color). All work must be wired. NO OTHER TYPE OF HANGING HARDWARE IS ALLOWED. See Wiring Diagram on page 3 of this document.
- Affix ID labels (using template on Page 4) and on the back upper left corner of each 2D piece of artwork. Each label must include: TITLE, ARTIST, MEDIUM, SIZE, PRICE, and YOUR CONTACT INFORMATION (QR code for payment, phone number or email). All labels must match your registration form.

#### ART DELIVERY AND PICK-UP


All art must be delivered to Berkshire Hathaway downtown Wilmington office. Address is 19-A Market Street, Wilmington, on Wednesday, January 22, 2025.

All artwork must be picked up from Berkshire Hathaway, on February 25, 2025.

Berkshire Hathaway is a small but busy office and we may need to stagger drop-off and pick-up times to minimize disruption to their business. Exact drop-off and pick-up times will be announced with the acceptance notices. Neither Berkshire Hathway nor WAOTC has the means to store leftover artwork. If you have a conflict, please make arrangements with another participating artist or with someone else to pick-up your art. Artwork that is not picked up on that date will be subject to a late fee of \$25.00
