COMMANDER'S CORNER

As many of you may know our Post often recognizes and awards our local Law Enforcement and Fire Fighter/EMT personnel for a job well done. What you probably don't know is that we recently had a local Fire Fighter who was not only our Post winner, a District Winner, and a State Winner, but he made it all the way to be a NATIONAL winner! This is a FIRST for our Post and a huge complement to this man's accomplishments. Our Post set up a time to meet Wade and his superior officers to present his National Award which included a Plaque, a Certificate and a check for \$500. The Post presentation team consisted of Casey Kleindienst, Harry Steelman, AJ Summa, Robert Casillas and Rene Macare.

Wade Munson works at Orange County Fire Authority Station 45 in RSM and he comes from a family with a long line of Fire Fighters. Not only did Wade show exemplary performance as an EMT but he also planned, built, and launched a new behavioral wellness program incorporating a department Therapy Dog for his Fire Station. Wade received PAX, a 3-year old lab retriever, through the Thor's Hope Foundation and worked tirelessly as a volunteer to learn about how to set up a Peer Support Canine Program. Wade became Orange County's first Canine Peer Support Specialist using PAX in his department station to help diffuse crisis level behavioral health events (we know this better as PTSD in the military after experiencing life crisis events in combat). Fire fighters and EMT's face daily crisis events and deal with death, suicides,

horrible car accidents, and destructive fires then come back to the station with a lot of stress, anguish, etc. and it's a great relief for them to have PAX there waiting for them to help relieve the day's experiences...

Wade is helping other Fire Stations to put similar programs in place to help them deal with the stresses of being a Fire Fighter/EMT with the Fire Authority. He also co-founded a group that cross trains facility canines for Peer Support functions between other response agencies (law enforcement, fire, hospital, and EMS). We could not be more proud of Wade's accomplishments, and for him to make it all the way to the National level VFW award is just indicative of his drive and motivation for success at whatever he sets his mind to accomplish.

<u>VFW National Convention:</u> Once again, I was granted the opportunity to attend the VFW National Convention and represent our Post. I consider this an honor. I learned quite a bit about how the VFW operates and how we support both our members and the veteran community at large. The convention was held in Louisville, KY, July 27-31. Here is a synopsis of what I did while I was there:

I started on Saturday with registration and the Western Caucus - a meeting of representatives from the about 10 western states to determine nominations for two National officer seats (There are 4 Conferences representing the Departments.) We developed nominations for the Jr. Vice Commander and the Judge Advocate General. On Sunday, I attended the solemn Annual Memorial Service and later the Member Rights/Post Commander Authority Workshop. The focus was almost entirely on member rights.

Monday was the Joint Opening session with a number of very interesting presentations from distinguished members and partner organizations. In the afternoon I attended the Parliamentary Procedure Workshop and also spent some time browsing the many vendor exhibits.

Tuesday morning started the Business Sessions which ended up lasting longer than expected due to the call for a roll-call vote on one of the Bylaw change proposals. This was the first roll call vote on a Bylaw proposal in nearly 30 years! The motion was regarding the voting majority required by the Council to Approve the National Commander-in-Chief's appointment for the position of Adjutant.

I finished up on Wednesday with the morning Business Session including the Nomination of Officers and a VFW National Home Workshop in the afternoon.

I am always available to discuss any of the sessions I attended. If you are ever have the opportunity, I highly recommend you attend one of these conventions.

<u>Lifetime Service Award:</u> Post Charter Member, Frank McCleary was honored at our July meeting for his years of dedicated service to our Post. Frank is currently our Officer of the Day, a position he assumed in July 2018. Prior to that he served as Trustee for three years.



Frank, a US Army veteran, served in Vietnam from 1967-69 and was assigned to the 82nd Airborne, stationed near Da Nang in Phu Bai. Frank received a Bronze Star and other decorations for his heroic service.
