#### PREFACE

This study has been made to account for the development of Masonry in Broken Arrow, from the period of Indian Territory into early Statehood of Oklahoma.

This presentation has been gathered from old Lodge books and correspondence, information from the Grand Lodge of Oklahoma A.F. & A.M., old "Broken Arrow Ledger" clippings, Historical Society information, H.C. Rhoades "Establishment and Development of Broken Arrow OK., conversations with "Old Timers" and their families in Broken Arrow and other available sources.

I like to thank all the above contributors and the many Brethren of my Lodge, who took part in this research.

Broken Arrow was located in the Creek Nation of the Indian Territory and established through some smaller settlements and their citizens. Like many towns, when the Railroad started coming through, the development of settlements changed into Townships. Many people abandoned or moved into these new areas and started over again. Railroads opened up a new opportunity for many, in travel, access to markets, movement of goods etc.

Broken Arrow was platted in 1902 and in 1903 the Rail System reached it, the Missouri, Kansas and Oklahoma Railroad, later KATY.

With the establishment of the Arkansas Valley Townsite Co. in August 1902 Broken Arrow was no exception. From a trading post in the 1800's it grew into a town by 1903. The deed for the Townsite was approved by the Secretary of the Interior in October 1903. The Arkansas Valley Townsite Co. was selling sites and lots in 1903 and some people immediately had business structures erected.

In six months businesses operating in Broken Arrow included three hardware stores, a dry goods store, two grocery stores, a hotel, three drug stores, two banks, two lumber yards, a general merchandising store, two cotton gins, a coal yard, an elevator and two restaurants. There were four doctors to serve the community. During the first two years population increased rapidly. In 1907 at the time of statehood, Broken Arrow had a population of 1383.

Many of the people that had come to Broken Arrow were already knowledgeable in Masonry or were members of Lodges throughout the territories or in other states. Cecil Rhoades stated this in his book very eloquently: "In the horse and buggy days, 'lodge night' was a red letter date on the calendar of the average citizen. Lodge members often traveled many miles in order to be able to attend lodge meetings. The lodges of Broken Arrow have thrived under the most adverse circumstances, supplying a genuine need for fellowship, service and achievement within the order."

The Masonic lodge in Broken Arrow was not the first fraternal organization in this town, but it appears it was there very early. The "Ledger" reports:

THURSDAY, April 30, 1903.

There are now three fraternal societies which have organizations here. The Modern Woodmen, Odd Fellows and Woodmen of the World, and we understand the Masons are talking of instituting a lodge in the near future.

A number of brethren of the Masonic order, Dr. R.S. Plumlee, J.B. Parkinson and Frank C. Boles, who resided in Broken Arrow, met Monday, May 11, 1903, in the hall over the Hill Mercantile Store and made preliminary arrangements for organizing a Masonic Lodge in Broken Arrow.

It is interesting to note, that the Hill Mercantile Store is the same place as the old Farmers Trading Co. building, which was built by S.E. Orcutt in 1903. According

to abstract information, the location of this building was in Block 47, lot 2,3,4 and 5 and is the location of todays lodge building.

On June 8, 1903 the committee of Dr. R.S. Plumlee, R.A. Waller, Frank C. Boles and G.L. Holt went to Catoosa to meet with some Masons to establish contact with a travelling Representative of the Grand Lodge. This was not successful until November of this year.

When Dr. Plumlee made the next trip to Catoosa on November 19, 1903 he had an appointment to meet B.G. Martin, the Grand Lecturer of the M.W. Grand Lodge, A.F. & A.M. He made arrangements with Mr. Martin to begin a series of lectures in Broken Arrow at nine o'clock next Thursday morning and all Masons were invited to attend these lectures. It was hoped that a local Lodge would be organized at the close of the lectures. It was not until December that the lodge was approved by Grand Lodge "Under Dispensation".

From the 1904 Grand Lodge Proceedings:

SPECIAL DISPENSATION TO ORGANIZE NEW LODGES.

December 10, 1903, to Roscoe S. Plumlee, W.M., Josiah B. Parkinson, Robert A. Waller and twelve (12) others, to form a new lodge at Broken Arrow, Indian Territory, to be known as Broken Arrow Lodge U. D.

Grand Master of Masons and attested by Samuel Murrow and the seal of the Grand Lodge of the Indian Territory = which Dispensation is hereafter copied = the following Master Masons met at Orcutt Hall in Broken Arrow, Indian Territory at 8 o'clock P.M. Dec 25, 1903.

Plumlee Master, Brother Josiah B. Parkinson Senior Warden and Brother Richard A. Waller, Junior Warden, for opening the said Lodge and governing the same in the several degrees of Entered Apprentice, Fellow Craft, and Master Mason.

It is required of you our friend and brother, the Worshipful Master to take special care that all and every of Said Brethren of your Lodge, as well as those hereafter admitted into our body by your Lodge be regularly made Masons, and that they do observe, perform and keep all the rules and orders contained in our Book of Constitutions and that the Ancient Land Marks be strictly attended to, and further, that you cause to be entered in a book to be kept for that purpose an account of your proceedings with a list of those Initiated, Passed and Raised, or otherwise manage and transcribe a copy of the same with this letter of Dispensation to our Most Worshipful Grand Lodge at Annual Communication, for it expires by limitation on the first day of the session given at Atoka under my Hand and Seal of the Most Worshipful Grand Lodge.

Moved and carried by vote that the hour of meeting shall be from April 1st to October 1st at 8 o'clock P.M. and from October 1st to April 1st at 7:30 O'clock P.M.

Moved, seconded and carried by vote that the regular fee for Initiations shall be ten dollars (\$10,--).

Moved, seconded and carried by vote that the regular fee for passing to the degree of Fellowcraft shall be ten dollars (\$10,--).

Moved, seconded and carried by vote that the fee for raising each candidate to the degree of Master Mason shall be ten dollars (\$10,--).

Moved, seconded and carried by vote that the annual Dues of each member of this lodge be two dollars (\$2,00).


No further business appearing the lodge was closed in due form till our next regular communication, peace and harmony prevailing.

# THE FIRST LODGE OFFICERS.

Who were these first lodge officers and Charter Members? One has to check deeply into the communities history, the more we look into Broken Arrows early days, the longer the list of accomplishments and activities of our first members becomes. I don't think, we will find all the things we have to be grateful for, to these men. They were pioneers, businessmen, educators in many ways, community leaders and family men with a love for God and striving for successful future.

#### R.S. PLUMLEE

Dr. Roscoe S. Plumlee was the first Master of Broken Arrow Lodge and very instrumental in getting a Masonic lodge started here. He was a Physician and Surgeon, with special attention given to diseases of woman and children. His office was in the building of the Cottage Bakery. He had a membership in the lodge of the Broken Arrow Woodmen, the first fraternal organization in Broken Arrow.

In May 1903 the Broken Arrow Medical Society elected him to the post of treasurer and he started to build his home.

When summer came, things got very busy that year. He worked with others to circulate a petition for a town meeting with the purpose of nominations for the first city

election. On June 29, 1903 he was elected as aldorman of the community on the first city council.

In June 1903 he was elected treasurer of the Commercial Club, which was the first Chamber of Commerce in Broken Arrow. This organization also planned many activities during the year, fourth of July celebrations, Cotton Jubilee and many others.

I would think, to the regret of many, Dr. Plumlee demitted from Broken Arrow Lodge on October 13, 1905.

#### J.B. PARKINSON.

Josiah B. Parkinson was the first Senior Warden of Broken Arrow Lodge. His occupation is listed as editor and publisher. He came from Savannah, Illinois, where he demitted from Mississippi Lodge # 385. He was the third editor for the Broken Arrow Ledger.

In June 1903 he was part of the 4th of July celebration committee, he was very active in community work.

As the result of Broken Arrows first city election he became the first Mayor. In 1904 he started a tree planting program within the town. These trees were dug up along creek beds and were then planted within the city limits. Beside his mayoral duties, other not so pleasant tasks had to be performed, such as assessing fines against unruly citizens.

Parkinson became Master of Broken Arrow Lodge for the year 1912 and served thereafter 4 years as Secretary of the lodge from 1914 through 1917.

#### R.A. WALLER.

Richard A. Waller was the first Junior Warden of Broken Arrow Lodge. He seemed to have owned the Owl Drug Co. The Mounds Monitor quoted him in 1903 that the business in this new town was good.

On June 25, 1903 he moved into his new residence on East Commercial Avenue. This same June he was also elected to the first Broken Arrow city council as alderman.

He served in several position in the lodge and became its Master in 1905 - 1906.

#### H.L. PIERCE.

Hiram L. Pierce was the Broken Arrow Lodges first treasurer under dispensation and one year later in Broken Arrow Lodge # 141.

In August 1903 he was elected to Broken Arrows first Board of Education. Thereafter he became Broken Arrows second Mayor and served his term from June 1904 to June 1905.

Granville L. Holt was Broken Arrows Lodges first Secretary. He and his wife Sally were members of the Order of the Eastern Star here. He served as Worthy Patron in 1907 with Worthy Matron Mrs. Emma Blair.

His occupation is listed as lawyer and his office was located at Holts drug store on south Main Street. In 1903 he acted as authorized agent on behalf of the petition signers for Broken Arrows incorporation.

In August 1903 he was elected to Broken Arrows first Board of Education and became the first President of this board.

In March 1904 he was elected Trustee of the First Missionary Baptist Church in Broken Arrow.

#### Wm. G. McGechie.

William G. McGechie was one of the first Stewards at Broken Arrow Lodge. He also served the lodge as chaplain.

His background is particularly interesting since he came from a foreign country. He was born in Scotland and came to the U.S. in 1857. The family settled in Ohio and later moved to Nebraska. While in Nebraska, he became a dentist in 1901 or 1902. He sent his son to Oklahoma, to claim land that was opened for settlement. Three to four months later he followed. The land claimed were 320 acres on

the southwest corner of 81st and 161st. He brought cedar trees with him from Nebraska and planted them all around the farm. Here, at Cedar Ridge Dairy he raised a large herd of cattle.

He also applied for a patent on medical tonic and ointment used on sore muscles.

He was also constructively active in the community and when the first church went up in Broken Arrow he was part of it. In 1903 he and two others used their wagons to haul lumber from Catoosa for the building of the Methodist church.

He was also a member of the Order of the Eastern Star with his wife Anna. In 1906 he was the second Worthy Patron of chapter # 140 with Worthy Matron Mrs Emma Blair. He served again as Patron in 1911 and 1912.

#### CORNER STONE LAID.

Laying corner stones for public buildings is always a Masonic event. This opportunity came for the new lodge in Broken Arrow in August 1904.

By authority of a special dispensation to Brother Roscoe Plumlee, by Phillip D. Brewer, Grand Master of A.F. & A.M. of the Indian Territory, granting to said Brother Plumlee the authority to open the Grand Lodge aforesaid, in the town of Broken Arrow, I. T., therefore the said Brother did on the 7th day of August, 1904, open said lodge at the Masonic Hall of said place at 3 o'clock of said day, for the purpose of laying the corner of the public school house in said town.

BROOKS, Deputy Grand Junior Steward. JOHN B. GILLIS. Deputy Grand Chaplain. WILLIAM C. ADKISON, Deputy Grand Tyler. HIRAM L. PIERCE. Marshal.

The lodge was opened on the Entered Apprentice Degree and the brethren informed of the object of the communication. The lodge was then called off, and proceeded in Grand procession to the site of the public school building in said town of Broken Arrow, and there proceeded under the usual ceremonies, to lay the corner stone to said building, after which the procession returned to the lodge room and the lodge was closed.

The Broken Arrow Ledger reported this event on the 11th of August, 1904 from a different view:



Among these were a list of the members of the school board; a list of the members of the ladies school aid society; copies of the notes which were given to procure the cash for the erection of the building and a paper giving a brief history of the town and the manner of acquiring its name.

As things went on and new members were initiated the membership grew. The long awaited moment came, when the Grand Lodge of Indian Territory granted Broken Arrow Lodge the Charter. The Lodge was at that time assigned # 141.

## LODGE LOCATIONS.

As previously mentioned, the lodge started in the Hall above the "Hill Mercantile Store". This appears to be the Orcutt building where the Farmers Trading Company was also located at one time. That site is in block 47 and lots 2,3,4 and 5. Lots 2 and 3 are the locations where todays lodge is at on 117 West Commercial. What a coincidence to be again where it all started almost 90 years ago. This must have been a very busy place in 1903, several fraternal organisations met here, several church groups met in this hall and the meetings to organize the first city commission met there. At that time the Masonic Lodge subleased the Hall from the 1.0.0.F. for \$ 1.50 per month.

In January 1905 a committee was apointed to secure a new meeting Hall, consisting of:

J.B. Parkinson, S.W.,

G.L. Holt, Secretary and

H.L. Pierce, Treasurer.

In February, 1905, the committee, appointed to secure a Hall for the lodge for the ensuing year, reports that they have a proposition to rent a Hall over Lancaster, McAnally & Co. store at a rate of \$ 3.-- per month and recommend that said room be taken at said price, the said committee to continue and given full power to rent said room. Some good negotiating must have gone on, because in May we paid only \$ 11.50 for 5 months (\$ 2.30 a month).

The Broken Arrow Ledger had the following "News" item in the September 7th, 1905 issue.

9-7-65 A New Hall. The Masons have rented S. M. Allen's hall for a lodge room and as soon as they get their arrangements perfected they will meet there. Mr. Allen has extended the platform from the steps leading to the opera house in the rear and has made a door of one of the windows at the rear of the hall, thus making a very desirable hall. The Masons will rent it from Mr. Allen and will then sub-let it to such other lodges as may wish to use it. This will be quite an improvement for lodge purposes, because the present hall is used every night except Sunday and then it is impossible to accommodate all the lodges as frequently as they would wish,

The minutes on September 8, 1905 reflect that Brother Brown was to be issued a warrant to pay for his work in fitting up the Lodge. Another warrant of \$ 3.50 was allowed to pay the I.O.O.F. \$ 3.50 covering the last month rent. So the move to the S.M. Allen Hall had been made.

A committee sent by the O.E.S. asks to know, what amount of rent this lodge will charge them for the use of the lodge room. Said committee was ordered to report to said O.E.S. that the sum of \$ 2.50 would be charged per month, for said room.

Chairs and a table were purchased from Barth Mercantile Co. in the amount of \$ 91.11 and the warrant was approved to be drawn on the treasury.

The trustees were ordered to get the lodge room carpeted, as soon as sufficient funds were available. A motion to furnish "Cuspedors" for the Ante room and that all parties who chew tabacco, shall return to said room when chewing or smoking was by vote "tabled".

The following October it was approved by vote that the O.E.S. (Order of the Eastern Star ) and the W.O.W. (Woood Men of the World ) could rent the Hall.

A year later in 1906, the rental issue came up again and the motion not to rent the Hall anymore, was defeated by a vote of the lodge. The vote to rent the Hall to the Yoman carried.

January 25, 1907. The committee on Hall rent reported that Mr. S.M. Allen would rent the Hall to the Lodge at \$ 18.-- per month and Sanders Hall could be obtained for \$ 52.-- per annum and the Odd Fellows stand 1/3 expense of carpet. Committee continued.

In February the motion to accept N.L. Sanders contract for the Hall during the year 1907 carried. This appears to be a move back to the Lancaster, McAnally, Sanders & Co. building. It appears the Masonic lodge was now subleasing to other fraternal organisations and each had also to pay a percentage of the carpet.



Broken Arrow's Main Street, in about 1907, also owes its positioning, or repositioning, to the railroad. The small town, once called Elam, already was on the map when surveyors plotted the railroad's route, but was bypassed by several miles. Practical town fathers simply towed their town, buildings and all, to a site nearer the tracks.

It was not to be until 1919 that the Lodge was able to buy its own building. At that time, they purchased the building they had been in previously, the building that contained Allen Hall. It was bought from the Allen family in August 1919. This was our Masonic home until 1974.

# AN OLD LAND MARK REMOVED

The Old Farmers Trading Company Building Dismantled.

This week the old frame building formerly known as the Farmers Trading Company building was sold and is now being torn down and removed to to the country. It was purchased by Dr. Sh'ppey who will transform it into a barn on his farm.

This building was one of the first erected in this town. It was built by S. E. Orcutt in the spring of 1903. He occupied it as a store building. Later it was known as the Hill Mercantile Company. J. H. Hill of Cateosa furnished most of the money for the concern.

The upstairs of this building was used for an assembly hall. It was here that all church doings were held. All denominations were given the use of it. Sunday School was held there. Rev. Morris of Tulsa was the first minister who preached to the people. Such lodges as were then staited Here the Masons organized here and held several meetings there Later on as churches were built and lodge that constructed this room was vacated, and used as a store room in connection with the store

there it was that mass meetings and conventions were held. Here it was that the city's first officials were nominated.






#### fitz S. HURÒ.

Brother F.S. Hurd seemed to be a very interesting person. He started the first bank in Broken Arrow around 1902, the Traders and Planters bank.

He came originally from Kansas and out of the many Indian Territory towns he visited, he chose Broken Arrow to live. When he came here, he bought the lots where the First National Bank now stands and lots for his residence. His bank opened its doors to the public in December 1902, which became the First National Bank of Broken Arrow in 1904.

F.S. Hurd, the first cashier and later president of the bank, carried on practically all of the bank's business by himself. While the bank building was being constructed at its present location, he started business in a little building about eight by ten feet, which had been used for an office by the Arkansas Valley Townsite Company. Before the bank vault was installed, Hurd carried the bank deposits with him and kept them in a large room at the Simmons Hotel where he slept on the floor with several other men.

In 1904 he had his house build, located at 404 West Broadway Street. It remained in the Hurd family until July, 1985. This home is today one of the historic landmarks in Broken Arrow.


Hurd joined the Broken Arrow Lodge in 1905. He was very active in the lodge and was influential in his financial advise in the operation of the lodge. The secretaries minute book shows many occasions where he was trying to help in financing and finding a better lodge Hall for the meetings.

In July 1903, a city ordinance was passed to create the office of town marshall and treasurer, so Fitz Hurd was appointed treasurer.

He had two sons and both joined the Broken Arrow Lodge in later years.

Fitz Clark Hurd (F.C.), a bank teller became member in January 1915.

Paul Robert Hurd, a banker-farmer joined July 1916.




