PROPOSAL PROCESS AND SELECTION CRITERIA

Submissions will be reviewed by the Conference Committee.

All submissions will be evaluated on each of the following criteria:

- Overall topic and its relationship to the assessment/appraisal profession.
- > Learning objectives.
- > Program design/learning elements.
- > Overall quality.

### Submission Guidelines and Rules of Engagement

We are looking for sessions to provide content that will further our professional knowledge and increase efficiency in our offices. Presentations should include case studies or real-world examples and relate to jurisdictions across the state and various sizes.

Historically, conference presentations have been made up of 3-hour segments. We are happy to mix it up this year by putting together shorter classes and creating a montage of Mini Modules that bring together shorter informative sessions or combining two sessions together into a full day class if the topic requires more time.

Presenters who attend the conference for credit must register and pay the full conference fee. Presenters who attend only to give their presentation may not required to register or pay the conference fee.

Submit presentations to the Conference Chair, Victoria Sirota, IAO at <u>nyassessor.org/conference-proposals</u>.

Submission should include the following:

- A brief description or 2-3 minute video of your presentation.
- The primary point of contact. The person submitting the proposal will be considered the primary point of contact and will receive all communications from the Conference Committee. A brief bio including teaching experience, professional designations, jurisdiction, email, telephone needs to be included at the time of submission.
- List all the presenters at the time of submission. Include name, professional designations, jurisdiction, and company e-mail address. Biographical information will be requested after acceptance.
- Indicate the expected duration of your presentation and preferred date/time slot: 1 hour, 1.5 hours, or 3 hours on Wednesday, September 25, 9:00 a.m. 12:00 p.m. or Wednesday, September 25, 1:30 4:30 p.m. or Thursday, September 26, 9:00 a.m. 12:00 p.m.
- Use clear, appropriate, error-free language. Proposals require the title of the presentation, subject, short description, learning objectives, and how attendees will be able to apply learning objectives to their daily work. NYSAA may modify the titles and descriptions for editing and marketing purposes.
