Scott Shedler, IAO Installed as 75th NYSAA President

Scott Shedler's message at his installation ceremony was simple – challenge yourself to do better.

Shedler was named the 75th president of the New York State Assessors Association (NYSAA) in September 2019, and he shared that message during a moving speech following his swearing in. He has served NYSAA in a variety of capacities, but now that he has assumed the presidency his main objective is to challenge the NYSAA members to be better, to work together, and to achieve common goals in an effort to strengthen the organization.

"When you work together toward something greater than yourself, you find meaning and purpose," said Shedler, who has overcome life-threatening health issues to reach his current position. "When you continue to place the team first, everyone benefits. I realize that

sometimes our industry can be tedious and the process doesn't always produce excitement or the results we desire.

"The fact remains, however, that you are alive and you have a calling to do something with the rest of your

life starting now. The challenge is there. I have proven I can do it and so can all of our members. We can use our hearts, minds, and hands to build something bigger than ourselves. If you see something that doesn't look correct in the process, don't wait for someone else to fix it. Do it yourself and make a difference."

Shedler said he looks to <u>football coach Rob Mendez for inspiration</u>. Mendez has made a difference and so has Shedler, who has served as the assessor for the Town of Ramapo for many years in addition to his work with NYSSA. Shedler's duties and responsibilities as assessor, along with his work with NYSSA, have given him a unique insight into the intricacies of the job, and now he hopes to make the kind of impression that will push his members to change the way they approach their jobs.

"Our time is now," Shedler said. "The future belongs to those who prepare today. Prepare and work to do the impossible. Eleanor Roosevelt once said, 'You must do the thing you think you cannot do.' Be that person and do that thing. We live in service to our family, our churches, our town, and our county. We should focus that service on how many people we help each day and not how many likes we get on social media."

The Bylaws Committee has determined the following should be adopted into the NYSAA Bylaws under Article XII:

The NYSAA logo may be used to identify a member of the Association in good standing. The NYSAA logo may not be used to identify companies or groups that are not NYSAA member groups. The professional designation logos may only be used by designated NYSAA members in good standing.

The NYSAA logo may be used by NYSAA chapters in conjunction with chapter logos provided that the NYSAA logo remains unchanged and separate from chapter logos.

The NYSAA logo may appear on stationery and business cards of NYSAA members. NYSAA logos may not be incorporated as part of or assimilated into a business name, business logo, or corporate identity.

The logos may only be reproduced in the colors and formats provided by the Association.

The logos must not be altered except that they may be resized.

Exceptions: Any exception to these procedural rules requires express written permission of the NYSAA Executive Director.

Any violation of this logo use policy may result in remedial action.

The Employee Committee was tasked with finding a new executive director when David and Susan Briggs announced their unexpected departure on October 12, 2018. The committee discussed, reviewed, and interviewed candidates and made a recommendation to the Executive Board before hiring Warren Wheeler, IAO. The committee then interviewed and made a recommendation to the Executive Board for the position of director of communications and hired Tracy Carman.

NYSAA Ethics Committee Jeneen Hill, Chair

Since the 2018 Annual Conference, the Ethics Committee received two complaints against two members of our Association.

After a thorough review of the alleged violations of the NYSAA Code of Ethics and Standards of Practice, and the comprehensive and detailed written response from the accused, the Ethics Committee unanimously found that there have been no violations and that the complaints were without merit and were dismissed.

NYSAA Legislative Committee Maggie Alix, Chair

October – December 2018

ORPTS released the Mass Utility Ceiling Study. The committee teamed up with the Association of Towns (AOT) and worked to oppose state valuation of mass utility property. The committee submitted a Memo of Opposition, circulated an opposing resolution, and had a conference call with the Executive Deputy Commissioner of DTF. Fiber Optic Cable was ruled taxable. Two subcommittees were formed: RP-467 subcommittee and Dark Store subcommittee.

January - March 2019

The committee created a "How to Contact your State Representative Guide." The committee drafted a testimony for the Public Hearing with the Joint Commission of Senate, Assembly and Real Property Tax Committee members that was presented by Warren J. Wheeler, IAO and Scott Shedler, IAO.

April – July 2019

The committee wrote a response to the changes to STAR for media release. The press release, along with many others written by fellow assessors, were picked up and published across the state.

At the end of the legislative session another mass utility bill appeared on the agenda. Right away, we drafted a letter in opposition, and the Westchester Assessors Association and AOT supported the memo. The memo was sent to all the members of the Rules Committee, and the bill was blocked from going to the floor and is tabled for now.

The committee wrote a Memo of Support for PILOTs – requiring that assessment reduction school impacts be delayed by a year. This bill did pass both the Assembly and the Senate and has been delivered to the Governor.

July – September 2019

Most recently the committee has been working on our legislative approach to the cycle bill. The cycle bill has been on the legislative agenda for decades and the association has always been in support. Recently there has been expressed concern about the feasibility of conducting annual or cyclical reassessment due to lack of funding, staff, experience, etc. The committee is reevaluating the approach.

On September 10, NYSAA was represented at a roundtable discussion held by Assemblywoman Galef for the purpose of discussing A8201, which would exempt all equipment used for transmission and switching of radio signals for the provision of commercial mobile radio service or mobile internet access service.

Throughout the year we were contacted by several state representatives for a legislative position. We gave our position on legislation that included Solar (RP-487), electronic submission of ag exemption forms, bank codes, and golf courses.

There is a total of 53 new members for the past year. Thirty-two members were pulled from the list for nonpayment of dues, which leaves us a total of 827 NYSAA members.

Under direction of President Harris, our committee's first task was to evaluate the Association's website. This project was accelerated with the resignation of our executive director. Besides all the user issues that were brought to my attention, there were internal website management processes that were left unknown and needed to be figured out by the new Board. By February, we entered into a contract with GoDaddy to host and design a new, more user-friendly website. The committee is looking forward to end-user feedback so we can make the site as user friendly as possible.

The committee created a document to assist assessors with the audit process. This was after the chair traveled the state and spoke to assessors and auditors as well as other key stakeholders. The final draft was created via Joomag and was sent out for review. Once completed it may be sent out to the membership. The committee also interacted with the Legislative Committee.

Real Property Tax Administration Committee (RPTAC) J. Todd Wiley, IAO, Chair

The 2018-2019 RPTAC Committee consists of Rochelle Harris, IAO; Scott Shedler, IAO; Lloyd Tasch, IAO; Roger Tibbetts, FIAO; Warren J. Wheeler, IAO; and alternates Curt Schoeberl and Susan Otis, FIAO.

Meetings were held On October 17, 2018; January 28, 2019; and June 20, 2019. Our next meeting is October 7, 2019 in Albany. Primary topics discussed include legislation, tax relief checks & STAR credit checks, mandatory IVP, preventing STAR fraud & abuse, training, RPSV5/ACES, solar court cases, and many more.

It is noted that based on meeting discussions at RPTAC, the 2019-2020 state budget included a provision that adds a new section 1211 to the RPTL that streamlines the equalization process. Beginning with the 2019 equalization rates, if ORPTS confirms the assessor's stated level of assessment (LOA), the LOA will become the final equalization rate.

John H. Way – John M. Costello Memorial Education Fund Robert Criddle, IAO, Chair

The 2018-2019 trustees are Patrick Duffy, IAO; James Molinaro, IAO; Timothy Sheares, IAO; and Denise Spaulding, IAO.

The Fund trustees have been very busy since last year's fall conference working with the Association and IAO Board of Trustees to support and advance the Fund's educational mission. This work included the following:

- Agreed to provide 85% of the cost to rebuild the NYSAA website, not to exceed \$6,000, with the understanding that a digital education calendar will be developed and integrated into the website in place of the former paper calendar.
- Proposed an amendment to the Fund's Constitution and Bylaws authorizing the executive director or their designee to keep the minutes of all meetings of the Fund. Prior to this, there was no formal provision for keeping minutes. The Board of Trustees of the Fund and the NYSAA Executive Board approved the amendment.
- Completed an initial analysis of the vendor procurement process and the fee structure for fall conference vendors to determine if greater revenues and efficiencies can be obtained. This work is ongoing.
- Approved a request from the NYSAA Executive Board and IAO Board of Trustees for funding for the new John H. Way John M. Costello Memorial Educational Fund Training Center located at the new NYSAA office in Liverpool, New York. The training center will include an 86" interactive display system and greatly enhance and expand the delivery of education-al opportunities for the membership!

I am pleased to report that Fund, which is celebrating its 35th year, continues to be very strong financially under the professional guidance provided by our advisors at Merrill Lynch and the sound stewardship of the trustees. The 50/50 raffles, fall conference vendor booths, Fund Raffle Table, and Bulletin ads all help to promote quality education at one-day seminars, Cornell Seminar on Appraising, and the current Annual Seminar on Assessment Administration here in Lake Placid.

Twelve scholarship winners attended Cornell in July. The fall conference has four scholarship winners in attendance.

The total student count was 245. The 2018-2019 seminar coordinators are Robert Criddle, IAO; Dennis Ketcham, IAO; William Purtell, IAO; Denise Trudell, IAO; and myself.

To date there are 16 one-days being offered in 2019, eight of which are the Ethics class. Seven classes have been held thus far with 182 attendees. Additional Ethics courses will be added if needed.

Ethics and Bylaws Teri Ross, IAO, Chair

The 2018-2019 Ethics and Bylaws Committee members are Thomas Donato, IAO; Andrea Nilon, FIAO; Timothy Sheares, IAO; Lloyd Tasch, IAO; and Stephen Teele, IAO.

Please (see below) the proposed amendments to the IAO Constitution and By-laws to be voted on by the membership.

One IAO Ethics complaint was filed in July. This committee reviewed the complaint, as well as the accused's response, and has unanimously determined that there were no ethics violations perpetrated by the accused. It is our recommendation that the full Board of IAO Trustees approve the committee's decision and then the accused and accuser will be notified of that decision.

Proposed Amendment to the IAO Constitution and Bylaws.

At its April meeting, the IAO Trustees voted to accept the proposed amendment below (in red) to the IAO Constitution and By-Laws. In accordance with ARTICLE XI - AMENDMENTS, this amendment is presented to the IAO members for their consideration. This proposed amendment will be voted on by the IAO membership via IAO election ballot.

Original version:

ARTICLE V Election of Trustees Section 1. New trustees shall be elected in accordance with the following procedure:

a. The chairman shall appoint a nominating committee composed of five members not more than two of whom shall be trustees and none of whom shall be members from the same county or city.

b. Forty days prior to the time of the annual meeting the Chairman shall cause to be distributed to each member by any means, including electronically, an official ballot showing the nominations of the nominating committee for each office and a space for alternates.

c. In order that a ballot be valid, all regulations must be complied with.

d. The polls shall close at the end of the thirty days following the date of the election notice. The ballots will be tabulated by three tellers appointed by the chairman.

Proposed amendment:

Section 1. New trustees shall be elected in accordance with the following procedure:

a. The chairman shall appoint a nominating committee composed of five members not more than two of whom shall be trustees and none of whom shall be members from the same county or city.

b. Any member of the Institute in good standing may submit an application, available from the Executive Director, to be nominated to serve on the Board of Trustees. All applications must be received by the nominating committee with a postmark no later than June 1st of each year. The nominating committee shall notify all applicants of their decision by June 15th of each year.

c. Any IAO member that timely filed an application and is not recommended by the nominating committee may file a petition to be added to the ballot. A petition, available from the Executive Director, signed by at least 15 current IAO members in good standing must be submitted to the nominating committee by August 1st of each year. A maximum of 5 signatures can come from a single County. The nominating committee will review petitions for validity and notify the Executive Director of their findings.

d. Forty days prior to the time of the annual meeting the Chairman shall cause to be distributed to each member by any means including electronically, an official ballot showing the nominations of the nominating committee for each office and a space for alternates.

e. In order that a ballot be valid, all regulations must be complied with.

f. The polls shall close at the end of the thirty days following the date of the election notice. The ballots will be tabulated by three tellers appointed by the chairman.

The Exam Committee held two exams this year, one in Greenburgh, Westchester County, and the other at the Cornell Seminar, Ithaca, Tompkins County. A total of 13 applicants sat for the exam and four candidates were successful in completing the exam requirements. The four candidates that have been recommended for membership by the Exam Committee are Tracy Farrell, City of Lockport; Michael Fouassier, New York City; Mary Beth Murphy, Westchester County; and Jenna Pettas, City of Long Beach.

Program & Technology Development Committee Dennis Ketcham, IAO, Chair

Our largest technological topic continues to be the website. A beta version of the new website was released to us over the summer, I've seen little comment made. As my 20th year as editor approaches, and as technology advances, perhaps it is time to have a discussion about the future of this publication. Although writing as someone from another generation who still reads the newspaper in paper format, delivery of this publication in booklet form may be an outmoded way of distribution, particularly since everything else the NYSAA and IAO provide are in digital format.

Historically it has been difficult to prod our members to pen articles. So as always, your editor is urging the Trustees to consider adapting a course they have written, appraisal they have done, office procedure they employ, or some professional experience they have had that may be helpful to others into an article for the Journal.

Recertification Committee Deborah Eurich, IAO, Chair

The 2018-2019 Recertification Committee members are Michael Sommer, IAO and Craig Surprise, IAO.

The Committee currently reports 176 members in our database, which includes 70 exempt members. Current records indicate 17 members are required to recertify in 2019.

Members lacking credits for 2019 received notice of their credit deficiency first in May, and a final notification in August. Members were given until September 30, 2019 to request an extension, or to provide proof of credits completed in the appropriate time period no later than October 31, 2019, or be removed from membership.

The committee has prepared recertification packets for the new members receiving their designations at this 2019 Fall Conference. The committee congratulates and welcomes these new members to the Institute.

Training Advisory Committee Cathy L. Conklin, FIAO, Chair

The 2018-2019 Training Advisory Committee members are Roger Tibbetts, FIAO; Denise Trudell, IAO; and John Zukowski, IAO.

A Training Advisory Group meeting was held on Tuesday, September 17, 2019. Prior to the meeting, ORPTS had sent all members a training needs report dated August 23 and an analysis of the survey results from online offerings of Assessment Administration (April 2019) and Mass Appraisal (June/July 2019). Roger also distributed a report of IAO course offerings.

Cathy noticed on the needs report sent to the group that there were several appointed assessors who were far beyond the required by date for completing a component of training. She questioned whether ORPTS was undertaking any enforcement on appointed assessors. Dave acknowledged the problem and advised the group that once a year he reviews the list and sends a non-compliance letter to both the assessor and their supervisor. At the end of the year, Dave sends a list of those assessors not in compliance to Legal, where no enforcement action has been pursued. We have "required" education but no enforcement since ORPTS merged into T& F.

Dave & Sean pointed out there is a distinction in procedure regarding qualifications for appointment vs. basic education. If a candidate for appointment does not meet the qualifications, ORPTS will so advise the municipality. If the municipality appoints that individual anyway, ORPTS will not list and does not recognize the appointee as the assessor but as local staff only.


