On Thursday, October 5, 2023, Maggie Alix was installed as NYSAA's president for 2023/2024. Below is her acceptance speech:

Good evening,

First let me take this opportunity to congratulate 1st Vice President Rob Bick, 2nd Vice President David Roach, and Board Members Lisa Goree and Jill Murphy. Board Member Joshua Herman will be sworn in, in the near future. I look forward to working with you and the entire Executive Board in the coming year.

I am honored to be the 83rd President of the New York State Assessors Association. I am humbled by this opportunity, and by the amount of support I have here tonight.

This time last year while in Lake George, Past President Lloyd Tasch said to me, it's a good thing we're having your installation at a city center, knowing all too well that my family would be here in full support. My mother Jill; my sister Abby; brothers Michael and Dan; my sisters-in-law Tanya, Amy, and Christina; and my

Uncle Jerry have joined me this evening. In addition, I have my dear friends the Karwiels and my friends and colleagues from the Town and Village of Green Island. 



Our summer conference on professional development was a huge success. We managed to hit our budgeted profit target. NYSAA Standing Committees

NYSAA Auditing Committee Deborah Eurich, IAO, Chair

The 2022-2023 Auditing Committee consists of John Noto, IAO and Marianne Owen-Feely.

The Audit Committee met on June 26, 2023 via Zoom to inspect and audit the fiscal 2022 financial records of the New York State Assessors Association, the John Way/John Costello Memorial Education Fund, and the New York State Chapter of the IAAO.

Treasurer Laverne Tennenberg, IAO supplied all financial documents in advance of the meeting to provide the committee with adequate time for review, and responded to all questions asked by the Committee during and prior to the meeting. President Christine Hayes also joined the meeting, offering insight and answering questions for the Committee.

The Committee discussed the New York State Chapter of the IAAO, noting that it continues to be inactive, with a balance in the treasury, however an IAAO course is scheduled for Cornell 2023.

The NYSAA Capital Asset List was reviewed and found to be current. Recommendations for policies regarding asset purchases, retention, and disposal were provided to the Board.

After reviewing the financial records of the New York State Assessors Association, the Way-Costello Memorial Education Fund, and New York State Chapter of the IAAO, the committee found no discrepancies and agreed that these accounts are accurately maintained and are presently in good order.

Thank you to fellow committee members John Noto, IAO and Marianne Owen-Feely for their able assistance. The committee again thanks Treasurer Tennenberg for a commendable job keeping NYSAA's financial records in order. Thank you for the opportunity to serve the NYSAA with this important assignment.

NYSAA Constitution & Bylaws Committee Lisa Goree, Chair

The 2022/2023 Constitution & Bylaws Committee consists of Thomas Donato, IAO; Tracy Farrell, IAO; Rochelle Harris, IAO; William Purtell, IAO; and David Roach, IAO.

Below is a summary of the NYSAA Constitution and Bylaws amendments approved at the Annual Meeting on October 4, 2023.

- *Article 1 Section 1:* Add: The NYSAA shall be managed by the Executive Board as outlined in Article IV.
- *Article 1 Section 2:* Change objectives to mission.
- *Making the by-laws to conform to gender neutrality:* Changing all occurrences of him/her and himself/herself to themselves or the member throughout the entire document.
- *Article 3 Section 2:* Add: The term of the President shall be (1) one year.
- *Article 4 Section 9:* Add section 9 as follows: A sitting Executive Board Member cannot simultaneously hold a seat on the IAO Board of Trustees or The Fund Trustee Board.
- Article 6 Section 1: Add line: The President or their designee shall act as the official spokesperson in matter of public policy, liaison to outside local & state agencies and preform all other duties necessary to carry out the duties of the NYSAA.
- *Article 10 Section 1 Paragraph A:* Add: A notice of the annual meeting shall be sent by the Executive Director to all NYSAA members at least 10 days in advance of the meeting.
- Article 12 Section 7: Add section 7 as follows: E-mail communications:

All e-mail communications to the general membership will be sent to the Executive Director and President for review. Any NYSAA member (Regular, Associate, Life, Honorary, Affiliate, or Retired) must seek approval from the Executive Board to communicate with the general membership via the e-mail distribution list. If approved, said email shall be distributed by the Executive Director. Use of the general membership e-mail for campaigning purposes is prohibited.

- Article 13 Section 1: Code of Ethics Paragraph 3: Add line: Use caution to avoid the appearance of impropriety, even if no such act exists or is intended.
- *Article 13 Section 2 Paragraph 1:* Add Line: the member shall be dedicated to excellence in assessment administration and equal distribution of real property tax.
- *Article 13 Section 2 Paragraph 4:* Add Line: To strive for the individual & collective recognition of the assessing field as a profession and continually seek to take advantage of educational resources and networking opportunities with assessing professionals in the state.
- **Rules and Regulations Section 2:** Add Line: The Constitution & By-laws of the New York State Assessor's Association will supersede any local chapter's Constitution and By-laws, if there are any conflicts or omissions.

NYSAA Ethics Committee Thomas Donato, IAO, Chair

The 2022/2023 Ethics Committee consists of Lisa Goree; Josh Herman, IAO; James LeGrett; David Roach, IAO; Daniel Ross, IAO; and Teri Ross, IAO.

It is with great pleasure to report that the Ethics Committee has had no viable complaints or concerns requiring review or action during the 2023 year.

NYSAA Legislative Committee Maggie Alix, Chair

The 2022/2023 Legislative Committee consists of Rochelle Harris, IAO; Josh Herman, IAO; Andrea Nilon, FIAO; John Noto, IAO; Daniel Ross, IAO; Curt Schoeberl; Scott Shedler, IAO; Shanelle Washington; Heather Weinhold; and Todd Wiley, IAO.

Here is a recap the committee's work over the past year:

Ended the 2022 calendar year with the Governor vetoing the Condo Bill A03491B/S05946B, and signing bill A01980/S01980; requiring a second notice of tax exemptions for senior citizens.

In January, Sen. Michelle Hinchey, District 41, introduced "The Short-Term Rental Registry Act"; which generated a lot of questions and sparked the committee's interest. The committee was interested in including language to allow an assessor the ability to modify assessments based on change of use. The committee went on to prepare a panel to present "Short-Term Rentals and Assessing as Commercial Property" at the AOT conference in February.

The Executive Budget had two components that were of interest to the assessment community:

Part K: simplifying and modernizing the definition of income for the senior citizens exemption

- The Association put forth a tremendous grassroots effort to oppose the provision. Although the provision was not eliminated from the budget, the committee was able to get changes made before the final adoption.
- The Association hosted a webinar to explain the new income calculation, and worked collaboratively with DTF to do a question and answer email.
- The Association continues to work on implementing changes to the application forms/worksheet.

Part N; clarifying that adoption of the solar and wind energy system appraisal model is not subject to the State Administrative Procedure Act (SAPA)

• This provision codified the state's solar and wind valuation model into law.

Additional tasks:

- Submitted written testimony for the Joint Public Hearing on Taxes
- Met with the new Chair of Real Property Tax, Jamie Williams, on a couple of different occasions: to review the Association's Legislative Agenda and to explain the need for the Staggered Exchange Bill.
- Met with Assembly Member Zebrowski and staff regarding the Staggered Exchange Bill and the need to clarify the language in the firefighter's legislation. The intent of the law is not clearly stated in the language, leaving too much room for interpretation.
- Discussed with the sponsor of the second notice bill the need to amend the language to narrow the pool of recipients receiving notice, methods of notification, and the timing of the notice.

The New York State Assessors Association gained 87 new members in 2023. There were 68 non-renewals mostly due to retirement and consolidation of assessment boards. We have a net gain of 19 new members with a total of 937 members.

Last year 23 counties reached 100% membership. This year there are 25 counties with 100% membership.

Legislative Update:

Budget items:

The use of the ORPTS solar calculator is now mandatory for solar projects. Many assessors are having difficulty getting the info needed for calculator input. Tobias Lake from ORPTS legal will check with NYSERDA to determine if the info is available from other sources.

ORPTS Farm Course:

Rochelle Harris, IAO will be meeting with the ORPTS staff that updated the Farm Course to determine if assessor input is needed.

RPS Online:

Some potential screens were shared with RPTAC and the Governance Committee. The tentative release date for Phase 1 is sometime in 2025.

RPSv4:

Assessors requested more reasons be made available for closing IVPs—ORPTS staff is working on them.

Volunteer Firefighters Exemption: discussion about V4's ability to proess the exemption correctly—per ORPTS functionality should be completed by fall.

Karen Quinn from ORPTS is now the lead for RPSv4.

STAR Reports:

Karen Quinn and Teri Ross, IAO will be working on various STAR reports to hopefully make them more user friendly.

The Fund Trustees worked over the past year with the Association and IAO Board of Trustees to support and advance The Fund's educational mission through the following activities:

- Approved requests for financial assistance totaling \$1,745.90 to support and enhance the delivery of hybrid learning. This included various equipment, two (2) Epson projectors, portable microphone, and three (3) portable screens.
- Awarded fourteen (14) scholarships for attendees at the 2023 Cornell Seminar on Appraising, two (2) of which were new for individuals who challenged the IAO course and test and four (4) scholarships for this Annual Conference.

The Fund continues to be very strong financially experiencing a relatively moderate increase overall of 7.82%. This is due largely to the professional guidance provided by our advisors at Merrill Lynch and the sound stewardship of the Trustees. Merrill Lynch account balances as of August 31, 2023 were:

Total \$341,502.18 (13.01% increase from December 31, 2022)

the very capable hands of Edye McCarthy, IAO as Chair. This committee has been working very hard dissecting and data mining to bring the best classes to you. There will be some very exciting changes and classes coming your way as this committee progresses.

Cornell was very successful this year. The Hotel did an amazing job, as did our instructors, and a few new and challenging courses were offered. We were successful in reestablishing a relationship with Cornell staff, and I would like to thank Dennis Ketcham and his committee for putting together a wonderful array of classes at our summer training. The IAAO class was a HUGE hit, and we hope to continue bringing that high caliber training to you!

Victoria Sirota, IAO has been a very busy Trustee; she and her committee have put together a stellar slate of classes for our conference. She has worked very closely with Brian Phelps, IAO to bring some exciting new technology to our conference.


