



2027 PRIVATE EVENT RATES

NON-ALCOHOL Private small event (up to & not to exceed 50 guests) – \$550/4hr.
(+ 5.5% WI Tax) (Rental times when you arrive and leave)

NON-ALCOHOL Private small event (up to & not to exceed 100 guests) –\$1000/4hr.
(+ 5.5% WI Tax) (Rental times when you arrive and leave)

NON-ALCOHOL Private small event (up to & not to exceed 200 guests) –\$1500/4hr.
(+ 5.5% WI Tax) (Rental times when you arrive and leave)

NON-ALCOHOL Private small wedding event (up to & not to exceed 100 guests) –\$2000/5hr.
(+ 5.5% WI Tax) (Ceremony, Dinner, Dance)

****Additional hours- \$250/hr. after 4 hours (Rental times when you arrive and leave)

Due to our permitting, we are only allowed Six (6) days per year, One (1) per month to allow alcohol.

ALCOHOL Single day private event with alcohol– Same as weekend rate (due to our permitting)
(up to & not to exceed 200 guests) - \$3500/6hr. (+ 5.5% WI Tax) May be booked on a Saturday
(Over 20 guests attending, a Bartender is required- \$25/hr.)

VENUE AVAILABILITY FOR 1 DAY EVENTS – Mid-May to Mid-October

Thursdays 5pm-9pm

Fridays 10am – 3 pm (all items must be cleaned up, and everyone vacated no later than 3:30-
unless no other events booked)

Sundays 11am- 4pm (if no other event is booked prior on Saturday you may start at 10am)

ADDITIONAL/OPTIONAL FEES (see private event policy)

Set up & Tear Down- \$150

Trash dumpster fee - \$125

Clean up- \$150

Table Linens - \$10/linen

DAMAGE DEPOSIT: A \$250 deposit for non-alcohol events or a \$500 deposit for alcohol events is required. May be fully refundable, dependent on any damage, stolen property of FT or excessive cleaning is required. The client will be held responsible for any damage caused by your guests during your event dates. This is due with final payment, 30 days prior to event.

DEPOSIT & REQUIREMENTS: To hold your date, a deposit of 50% of rate + 5.5% WI sales tax and a signed contract and policy must be submitted. The deposit is non-refundable after 7 days of date of contract. Cancellation: If the CLIENT needs to cancel, FT will allow date transfer within 1 calendar year, from booked date. (if available)

The remainder final payment, the total due, damage deposit, any other additional services, plus WI sales tax of 5.5% and proof of event insurance is due at least 30 days prior to event date. These fees are nonrefundable;

Payments allowed – Cash (if dropped off), Cashier's/certified checks
