The Parent/Guardian will indemnify and hold harmless Prairie People Nature Learning from any damage, loss, liability, legal costs, and other expenses that Prairie People Nature Learning may suffer or incur by reason of any claims against Prairie People Nature Learning arising or connected, directly or indirectly, with the student's participation in the outdoor activity program.
