Defending The Defenseless-Veterans-Elderly-Youth
Veterans Son Prison Reform Plan

British politician Lord Acton said, "Power tends to corrupt and absolute power corrupts absolutely." King Lemuel's mother understood that a person's character is often revealed in how he treats the underprivileged.

"Speak up for those who cannot speak for themselves; ensure justice for those being crushed," she urged (Proverbs 31:8)

"Remember those in prison as if you were together with them in prison, and those who are mistreated as if yourselves were suffering," (Hebrews 13:3)

1. There needs to be a separation of the elderly which are defenseless against violent gangs and other predators (ISIS want to be's) etc. Currently there are 86 year olds, some blind. Some on walkers, in wheelchairs, without legs etc. thrown in with the most violent gangs. With brittle bones the elderly require hip surgeries and metal plates placed in skulls due to violent attacks at a large cost to tax payers because FDOC has no plan for classifying elderly housing. With black leaders on the street calling for the murder of white police and whites in general (veterans and their families) etc, it is especially dangerous for the elderly in prison where an accurate census would show pure whites are out numbered 10 to 1 and elderly whites being the most targeted and injured.

FDOC currently has two 50 and older institutions- Union CI located in the center of Florida and Zephyrhills CI located in south Florida. Florida eliminated parole in 1983 and since then its prison population has tripled! The growth of elderly prisoners with family in the north west panhandle wishing to visit. Okaloosa CI and Century CI should be considered for 50 and older institutions.

- 2. In 25 years FDOC has eliminated most of its programs even eliminating most yard time, leaving nothing else for prisoners to do, but get involved in gang activity-(robbery, drugs, extortion, rape, etc...) and exhaust bottled up energies on inmates and staff, which cost Florida in blood. \$22,000 per life flight!
- 3. The faith based program is funded, only a few institutions have it, and those are not properly utilized in Florida today. Example: Columbia Annex CI is the most violent institution in Florida today. There is a faith based program in two wings of one building holding approximately 100 prisoners. Prisoners complete the program in 8 months are then ejected from a positive environment (faith based). Faith based is staffed by prisoners. A graduation program (multi level) must be created so that for those wishing to continue in their changed lifestyle and attitudes, they can continue to do so well in a positive atmosphere which can be created by establishing honor dorms and honor prisons. This would cost nothing, but simply using micromanagement of proper classification over prisoners. Those graduating from faith based programs should not be thrown into a digressive atmosphere but rather continue up a progressive ladder living in a dorm with like minded attitudes. Parole should be returned and set as a goal. If you have an entire prison full of individuals who have shown self discipline for a long period, then logic would dictate that such a prison needs less security personnel which would be more useful around more rebellious mentally handicapped prisoners. The above titles- 'faith based' and 'honor dorms' are interchangeable with 'incentive dorm; but an incentive dorm can be very unique in that a wing populated with respectful self disciplined men produce positive attitudes!
- 4. FDOC has regressed in a reverse cycle from the above graduation, example fore mentioned, to converting every institution it has into a (dead end) maximum security restricted movement death-traps (poor man's insane asylum) which in turn causes more stress and violence, thus recent riots and destruction to buildings (Sept 2016) due to major change in attitude state wide. Columbia Annex CI due to violence has to call an ambulance weekly and life flight once per month for three consecutive months. July, August and September 2016. (Statewide FDOC violence cost billions of tax dollars in

life flight-ambulance, surgeries, etc) \$22,000 per flight! August Wallen hung himself in 2009 at Gulf Annex, dorm P-1 due to his only avenue to relieve stress (jogging) was stopped under the state wide suppression of anything mentally stimulating (some yards closed for days at a time, where as they use to be open all day every day. 2018, Century CI, G- dorm no yard for seven day periods.

50 and older prisoners deteriorate mentally and physically faster in disciplinary confinement-5. (isolation cells). Such confinement needs to be reformed, given alternatives and restricted from use among the elderly. There have been 3000 prisoner deaths recorded in FDOC since 2000 (see heraldtribune/ also Dec 25, 2014 www.http:miamicbslocal.com), that should have triggered alarms that FDOC has built a disastrous production line which turns out nothing but psychopaths which will be 10 times more violent when returned to communities and cities. Jacksonville, Fl is an example of communities turned war zones, which will be a spreading trend under FDOCs current path. The psychopath's assembly line only benefits those who profit from its expansion – it has already tripled in just 25 years. Your help in reforming this death machine is requested? Reform will save billions of tax dollars and make communities safe again. Statistics show that elderly prisoners are not likely to return to crime, parole should be returned which would also save billions of tax dollars. Please contact your district senator to push this reform. Some very rare whistle-blowers no longer in the Fla Inspector Generals Office in 2011, exposed cover-up's of inmate murders by personnel. Exposed were the FDOC Secretary and Inspector Generals Office. The very department assigned to investigate FDOC perpetrators are themselves, perpetrators committing fraud and extortion on the tax payer!

Good behavior needs to be acknowledged and rewarded with an Incentive Dorm; What is the incentive for a prisoner (me) who has no discipline reports in 8 years, to behave if I am thrown into a wing /dorm made up of 98% gang bangers who have dozens of recent D.R.'s for drug use, stabbings, extortion, robbery (of other inmates) etc? I am 59 years old, there needs to be an 'Incentive Dorm' for self disciplined prisoners such as me and others.

What is the incentive or escape for a gang banger to separate from his destructive path if he is trapped all day on a wing made up of 98% gang bangers – etc? He is not going from one extreme of gang bangers to faith based dorm where there are no partitions between bunks nor shower? If he shows self discipline for a period of 6 months, he should be able to request a dorm change to an 'Incentive Dorm' which cost nothing!

On April, 14, 2020 the Fla governor called out the National Guard to ramp-up COVID-19 testing in nursing

homes; but no testing or separation of elderly prisoners! Those 70-80, and 90 years old should be released.

At Century C.I., gangs cut a ten foot metal bench into 2000 knives! This took place Aug 2018 in the day room area of G-1 dorm under the eyes of Warden J. Kolodzij and his gang Sgt. Charles Payne, via four plus cameras. For each knife used, it cost the tax payer \$22,000 just for one flight!

Inmates are oblivious to why FDOC does not enforce criminal charges involving inmate stabbings & possession of knives! Thus encourages violence and gang initiations, so it is a gang bangers training paradise! Violent gangs are the cultivators and pollinators through bloodshed, for the FDOC racketeers, money crop- people farming! Terrorist training ground at tax payers expense! What are you going to do about it?
