**DOG** Licenses need to be renewed yearly - Deadline is April 1, 2025. *All dog licenses expire on 12/31.*

After April 1<sup>st</sup>, a delinquent charge may be added. Check your dog's rabies certificate to make sure it is current.

Fines of \$50 to \$100 may be imposed for failure to have your dog(s) vaccinated.

Male or Female = \$12.00      Spayed or Neutered = \$6.00      Multiple Dogs (Kennel up to 12) = \$60 (extra dogs \$6 ea.)
