## TOWN OF EAU PLEINE, MARATHON COUNTY, WISCONSIN

## ORDINANCE NO. 108 OF THE TOWN OF EAU PLEINE ENTITLED "SECUREMENT OF MOBILE HOMES"

The Town Board of the Town of Eau Pleine, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Ordinance No. 108 of the Town of Eau Pleine entitled "Securement of Mobile Homes" is hereby created as follows:

## 108 SECUREMENT OF MOBILE HOMES

- (1) PURPOSE. Mobile homes historically have been susceptible to damage and/or destruction in the high and turbulent winds that are periodically experienced in the Marathon County area and, in particular, in the Town of Eau Pleine. The lack of securement of mobile homes to the real estate upon which they are located has been determined to be a major cause of such damage. This Ordinance is, therefore, intended to require the owner and/or occupant of mobile homes to adequately secure the mobile home to the property upon which it is located so as to afford better protection to persons in and about the mobile homes and their property.
- (2) TYPES OF MOBILE HOMES REGULATED. No person shall occupy a mobile home in the Town of Eau Pleine for residential or commercial purposes nor shall any person, firm or corporation locate a mobile home upon any property in the Town of Eau Pleine with the intent to use the same for human occupancy or permanent storage purposes without first having complied with the requirements of this Ordinance.
- (3) REQUIRED SECUREMENT. All mobile homes in the Town of Eau Pleine used for human occupancy or intended for such use and all mobile homes moved upon any property in the Town of Eau Pleine which are intended for human occupancy or permanent storage purposes shall, before occupancy or use, be secured to the real estate upon which they are located in one of the following ways:
  - (a) The home shall be bolted or otherwise secured to a frost wall which shall be constructed completely around the perimeter of the mobile home to a depth of not less than four (4) feet. Said frost wall shall be constructed of block, cement or wood and shall be placed upon poured concrete footings, or
  - (b) The mobile home shall have a basement with perimeter walls and footings constructed to standards as good or better than those specified in subparagraph (a) hereinabove.

- (c) Said mobile home shall be placed upon posts of no less than six (6) inches in diameter each and no more than eight (8) feet apart on center. Said posts shall be of treated wood or twelve (12) gauge metal and placed into the ground a minimum of four feet. The frame of the mobile home shall be bolted to each post.
- (4) PENALTY. Any person, firm or corporation violating any of the provisions of this Ordinance shall be required to remove the mobile home from the premises upon which it is located. In addition thereto, any such person, firm or corporation shall be subject to a forfeiture of not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) for each offense together with the costs of prosecution and, in default of payment thereof, shall be committed to the County Jail for Marathon County, Wisconsin, for a period not to exceed thirty (30) days. Each day a violation exists shall constitute a separate offense.

SECTION 2: Mobile homes located in the Town of Eau Pleine and used for living purposes upon the date of enactment of this Ordinance shall be required to comply with the provisions of this Ordinance only if an improvement or a combination of improvements to any such mobile home equals or exceeds fifty percent (50%) of the market value of the mobile home as of the time of the enactment of this Ordinance.

SECTION 3: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

 $\underline{\text{SECTION 4}}\colon$  This Ordinance shall be in full force and effect from and after its passage and publication as provided by law.
