DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Authority

This ordinance is adopted pursuant to the powers granted under Wisconsin Constitution, and Wisconsin Statutes including but not limited to Section 346.94 (5) and 346.95 (3). Further this ordinance is adopted pursuant to the powers granted to the town board under the grant of village powers pursuant to Sec. 60.22 of Wis. Statutes for the protection of public health and safety.

Section 2. Purpose

The purpose of this ordinance is to be able to enforce Wisconsin Statutes 346.94 (5) which states that no person may place or cause to be placed upon a highway any foreign substance which is or may be injurious to any vehicle or part thereof. This ordinance strictly prohibits plowing snow across town roads in the Town of Eau Pleine.

Section 3. Definitions

Definitions adhere to the descriptions provided in Wisconsin State Legislature, sec. 346.

Section 4. Penalties

Any person who violates this ordinance will be subject to a penalty of \$50.00 for each offense. Town of Eau Pleine Board has the capacity to give a written violation notice for the first offense and capacity to issue a \$50.00 fine for each subsequent offense, payable to the Town of Eau Pleine.

Section 5. Effective Date

This ordinance is effective upon passage, and the day after publication.
