- I. CALL TO ORDER: The Town of Eau Pleine monthly town board meeting was called to order by Chairman Mark Landwehr at 7:30 pm on August 16th, 2022, at the Town of Eau Pleine Town Hall, 111630 Equity St, Stratford, WI 54484. The clerk verified Proper posting of Meeting Notice and Agenda.

- **III. PUBLIC COMMENTS:** Alan Leffel asked various questions about road conditions which were answered by the board. He also requested a copy of one invoice and check.
- IV. MINUTES OF PREVIOUS MEETING: The town board had previously received copies of the minutes from the July 12, 2022 meeting.
 Motion/Second by KS/MR to accept the minutes as written. Motion carried.

V. TREASURER'S REPORT:

Shirley Hein read the Treasurer's report. Balance on hand as of 7/31/2022
General Account \$37,486.36, Tax Account \$5.89, Money Market Account
\$91,662.50. The Money Market Account contains two funds. Capital Projects
Fund Balance of \$15,197.17 and ARPA Fund Balance of \$76,465.33. (Note: the tax
account balance is as of 7/15/2022) Total Cash on Hand \$129,154.75.
Motion/Second by KS/MR to approve the treasurer's report as read. Motion
carried

VI. DISCUSSION REGARDING TOWN WEBSITE:

- The Clerk shared insights that it would be much easier to prepare the website
 herself rather than hiring an outside person since it would require a fair amount
 of her time to provide all the necessary documentation and then work together
 with someone else to format the website. She shared a draft version of a
 potential website we could use.
- GoDaddy.com cost of website hosting is approximately \$150 per year
- Motion/Second by KS/MR to publish the website with GoDaddy.com and pay the clerk a one-time fee of \$500 for website design and setup. Routine website maintenance will be part of the clerk's responsibilities going forward. Motion carried.

VII. TOWN HALL/SHOP IMPROVEMENTS:

- Motion/Second by MR/KS to accept the bid from Anderson Electric for new lighting in the shop. Motion carried.
- Two bids were received for painting of the large shop doors
 - Dean Ress for \$1500
 - Jerry's Painting for \$1850
 - Motion/Second by MR/KS to accept the bid of \$1500 from Dean Ress provided he has a certificate of insurance, and he can complete the painting by 9/13/22. Motion carried.

VIII. ROAD & SIGNS:

- Discussion regarding which roads need grading
- County bridge aid paperwork is due September 1st
- We may have to cut some trees for right of way for the bridge replacement. This
 needs to be done this fall.

IX. SANITATION/RECYCLING:

- We are still awaiting guidance from the state before we can proceed with the new Recycling Ordinance
- We will get one more load of granite for the parking lot at the Garbage & Recycling Center
- Motion by MR/KS to hire Lisa Schwarze to create and print a sign for the Garbage & Recycling Center at an estimated cost of \$150-\$200. The 3'x5' metal sheet to be used for the sign will be purchased from B&I Lumber. Motion carried.
