- I. CALL TO ORDER: The Town of Eau Pleine monthly town board meeting was called to order by Chairman Mark Landwehr at 7:30 pm on November 15th, 2022, at the Town of Eau Pleine Town Hall, 111630 Equity St, Stratford, WI 54484. The clerk verified Proper posting of Meeting Notice and Agenda.

- **IV. PUBLIC COMMENTS:** Various discussion about mud left on Hillside by manure haulers, the 2023 bridge replacement on Equity St. and hiring of part-time road patrol person
- V. MINUTES OF PREVIOUS MEETING: The town board had previously received copies of the minutes from the October 11th, 2022 meeting. Motion/Second by KS/MR to dispense with reading the minutes and accept them as written. Motion carried.

VI. TREASURER'S REPORT:

- Shirley Hein read the Treasurer's report. Balance on hand as of 10/31/2022 General Account \$10,439.66, Tax Account \$5.89, Money Market Account \$107,961.44. The Money Market Account contains two funds. Capital Projects Fund Balance of \$30,271.16 and ARPA Fund Balance of \$77,690.28. (Note: the tax account balance is as of 10/15/2022) Total Cash on Hand \$118,406.99. There is one unpaid invoice for a resident for \$827.10. Motion/Second by KS/MR to accept the treasurer's report as read. Motion carried.
- VII. CLERK'S REPORT: We will be receiving a credit of \$641 from "Focus on Energy" for the new lighting that was installed in the town hall and in the shop

VIII. ROAD & SIGNS:

- There was a large amount of mud and manure left on Hillside St. by manure haulers that were hired by Len Zawislan. In the future we will insist that they get it cleaned up right away. We will be billing Len Zawislan for the cost of the cleanup in this instance. In the future, we may consider hiring a third party to do the cleaning up in these types of circumstances.
- Motion/Second by MR/KS to hire both Cole Marten and Andrew Burke as parttime road patrolmen at a starting rate of \$20/hour after passing of background checks. Motion carried.

- Brian Forrest said Maple Ridge will continue to do the snow plowing at the Recycling Center this winter.
- We received many compliments from residents on the improvements made at the recycling center
- **X. ZONING:** Permit for new sign at Emmanuel Lutheran Church
