- Al Leffel had a complaint of manure and mud and manure left on Hillside St and Beauville Lane. ML will check with WTA to see what our options are for issuing a fine. Motion/Second by KS/MR to fine Len Zawislan \$350 for road cleanup on Hillside St and Lawrence Jones \$250 for road cleanup on Equity St. Motion carried.
- Gene Kautzer had a complaint of continuously barking dog owned by Steve Knauf. Motion/Second by MR/KS to issue a citation to Mr. Knauf in the amount of \$200 as per our town dog ordinance. Motion carried. Motion/Second by MR/KS to add an agenda item to our March board meeting agenda the possible repeal of our dog ordinance and possibly the adopting the county ordinance. Motion carried. This would allow county law enforcement to handle matters related to dogs. Tim Miller has offered to compare our ordinance with the county one and offer suggestions.
- Dan Seelow made a second complaint regarding Dean Ress' animals being loose and on the Seelow property. This has been an ongoing problem for many years.
