- V. TREASURER'S REPORT: Shirley read the Treasurer's report. Balance on hand as of 8/31/2024 General Account \$40,596.23 Tax Account \$5.56, Money Market Account \$80,430.47. The Money Market Account contains two funds. Capital Projects Fund Balance of \$51,076.44 and ARPA Fund Balance of \$29,354.03. (Note: the tax account balance is as of 8/15/2024) Total Cash on Hand \$121,032.26. Motion/Second by MR/KS to accept the treasurer's report as read. Motion carried.

VI. WIND FARM CLAIM:

 Marathon Wind Farm LLC has filed a court injunction to challenge our Wind Energy Facility Licensing Ordinance. We are required to respond by 9/18/24. There is a hearing being held at Marathon County Circuit Court on 9/17/24. Our insurance lawyer and the lawyer for the Town of Brighton are handling all necessary actions at this time.

VII. ROADS & SIGNS:

- Brush cutting is in progress
- The bridge on County Highway P near March Rapids Park is set to be replaced in 2026. The project will take about 3 months to complete.
- We will be submitting an application for county bridge/culvert 50/50 aid for new culverts on Abe Lincoln Ave.
