Tuesday, January 13th, 2026

- I. CALL TO ORDER:** The Town of Eau Pleine monthly town board meeting was called to order by Chairman Mark Radke at 7:30pm on January 13th, 2026, at the Town of Eau Pleine Town Hall, 111630 Equity St, Stratford, WI 54484. The clerk verified Proper posting of Meeting Notice and Agenda.

- III. PUBLIC COMMENT/INPUT:** Mark Wesle from the Farm Technology Days planning committee proposed two permanent driveways to be placed on the Redetzke's property for parking during the event. The board will continue discussion about this at the February monthly meeting.

 - Conversation about Act 71 which would allow the board to appoint Treasurers and Clerks instead of electing them has passed in Wisconsin. The board will research and discuss more at the February monthly meeting.

- VIII. SANITATION/RECYCLING:** The board continued conversation about increasing Randy Lau's wages for his position with the township's sanitation and recycling program. Motion/Second by KS/BR to increase his wages from \$15.00 per hour to \$20.00 per hour was made. Motion Carried.
