

# **PLEASE ENCOURAGE MN GOP EXEC BOARD TO LEAD WITH INTEGRITY**

State Central Delegates/Alternates,

Chair David Hann, Deputy Chair Donna Bergstrom and National Committeewoman Barb Sutter were served with documents for notification of their removal.

Rumors suggest that Chair Hann and his conspirators are refusing to re-issue the meeting call to include the Proposals for Removal of Officers from the upcoming Dec. 9th State Central Meeting so that they don't have to face the music.

Per our party's governing documents, the right and duty of Delegates to oversee Party Officers and the State Executive Committee are non-negotiable and non-assignable.

In compliance with Article XVI, Section 2, three State Party Officers have been served with detailed charges, along with specific questions. This service occurred more than 10 days before the scheduled State Central Committee meeting.

Because the officers were served more than 10 days prior to the scheduled meeting, the State Party is obligated, under Article XVI, Section 2, to include the statement of the charges and notice of removal for each of the three officers with an amended notice of meeting.

We are asking the State Executive Committee to intervene in this matter to ensure there is no interference in this process by those who face removal or by their supporters.

We are asking the Board to bring an end to the procedural maneuvering that serves to protect Hann and his allies personal interests, versus allowing for an open and transparent Democratic process.

Each member of the Board has a fiduciary responsibility to prioritize the Party's welfare over that of elected officers. The concerns brought forward must be

addressed openly at the December meeting, allowing Delegates to conduct due diligence and vote on each proposal.
