# Step 1:

## REMOVE CORRUPT PARTY OFFICERS & DEMAND PARTY COMPLIANCE

- Create a plan to ensure MNGOP Compliance with all provisions of newly amended MN Statute 200.02
  - ENSURE Required Compliance with:
    - MNGOP Constitution
    - MNGOP Rules
    - MN Statute 202A.12
    - MN Statute 202A.13
  - File AMENDED CERTIFICATION

### 2022 Minnesota Statutes

**202A.12 STATE CONVENTION, AUTHORITY OF.**

Subdivision 1. **Time of convention.** The final authority over the affairs of each major political party is vested in the party's state convention to be held at least once every state general election year at the call of the state central committee.

Subd. 2. **State central committee.** Subject to the control of the state convention the general management of the affairs of the state party is vested in the party's state central committee.

Subd. 3. **State executive committee.** The state executive committee of the party shall have charge of the administration of the party's affairs, subject to the direction and control of the state convention and the state central committee.

Subd. 4. **Constitution, filing.** The chair of the state central committee of each party shall file with the secretary of state a copy of the party's constitution and all amendments to the constitution as they are enacted.

# Proposed Duties of Stand Alone Compliance Committee

## Review

Review BPOU Actions and Governing Documents

## Verify

Verify ALL permanent delegates and alternates listed on Precinct Caucus certification forms from February 2022

- Were listed in credentialing documents at 2023 BPOU conventions
- Are listed in current delegate list

## Verify

Verify all BPOU Constitutions and Bylaws are consistent with Party Constitution

## Assess

Assess any removals of delegates and/or officers that occurred in 2022 & 2023 to determine if they were completed in compliance with Party & BPOU constitutions & BPOU bylaws

# Proposed Duties of Compliance Committee

## Review Congressional District Actions and Governing Documents

Ensure all Congressional District Constitutions and Bylaws are consistent with Party Constitution in same manner implemented related to BPOUs

Ensure any removal of officers or delegates were done in compliance with Party constitution and rules

# Proposed Duties of Compliance Committee

## Identify ALL Necessary Corrective Action

## to ensure subunits Are Compliant- Examples:

Noncompliant Action	Remedy Required
Disenfranchised permanent delegate(s) who were duly elected at the 2022 precinct caucus but excluded from participating in the BPOU Convention <i>(violation of MN Stat 202A.18; Party Constitution, Article II, Section 3; Article V, Section 5,A)</i>	Hold BPOU Convention within dates set by State Central Committee ❖ Hold all elections for officers and delegates ❖ Any votes taken to alter bylaws or constitutions must be revisited with the proper delegates credentialed
Removed permanent delegates or officers in violation of Party or BPOU constitution <i>(violation of MN Stat 202A.18,</i>	Notify delegates of wrongful removal and alternates of correct status
BPOU Constitution Conflicts with the Party	BPOU Convention meets to correct
