Timber Sale Notice Clear-Cut Pine and Hardwood Timber

Three Rivers Forestry has been contracted to sell the merchantable timber belonging to Venpra Corporation by sealed bid on approximately 41 acres, located 1.5 miles west of Lewisetta, on the south side of RT.624 (Lewisetta) and the East side of RT.625 (Cowart Road) in Northumberland County (see attached map).

A 10% sample cruise of the standing sawtimber and pulpwood has been made. All pine and hardwood trees 10 inches DBH and larger were tallied as sawtimber. All sawtimber volumes were calculated using the International Log Rule and pulpwood volumes are based on standard cords of 128 cubic feet. An estimate of the timber volume is provided; however, no guarantee is expressed or implied as to the actual timber that may be harvested due to individual utilization practices.

Bids will be accepted subject to the following conditions:

- 1. The purchaser will have **two (2) years** to cut and remove the timber from the date the contract is signed.
- 2. Timber harvesting will be done in accordance to Forestry Best Management Practices (BMP's) as stipulated by guidelines set forth by the Virginia Department of Forestry.
- 3. The owner requires proof of worker's compensation and liability insurance.
- 4. Landowner assumes responsibility for the VA. Seed Tree Law.
- 5. The timber purchase contract will be executed within 30 days of bid opening.
- 6. Access permitted by Ingress and Egress from RT.624 and RT.625 via the existing log deck and/or the farm road (see map).

Lump-sum sealed bids will be accepted **Friday**, **July 15**, **2016** at the <u>office of Three Rivers Forestry (990 Richmond Hwy, Tappahannock, VA)</u> at **3:00 PM** or by mailing to Three Rivers Forestry, PO Box 764, Tappahannock, VA 22560 or calling (434) 531-0456 prior to the sale. Mail bids should be marked **Sealed Bid, Venpra Tract**. Only sealed bids will be accepted and the landowner reserves the right to refuse any or all bids.

Prospective buyers are invited to inspect the timber at any time. Any questions regarding the terms of sale or location of the tract should be directed to Three Rivers Forestry.


