

Grant History Look Up Airport Improvement Program (AIP) - Airports

Instructions

- 1. Select a Start and End Date and Service Level (or State Project).
- 2. If you selected "Primary" as the Service Level, you can also select a Hub type (optional) if you want to see only airports of a particular hub type.
- 3. Select a State (optional) if you want to see data for a particular State or Airport. (If you selected a state, you will have the option of selecting a specific airport after submitting.)
- 4. Select Submit.
- 5. If you selected a State and want to see information for a particular airport:
 - Select the "View data for a particular airport" checkbox.
 - Select a Location Identifier or Airport Name (use Reset Airport to change your selection).
 - · Submit again.
- 6. Select Export to Excel to download a copy of the data.

Notes about the Data

- The grant data are generated at the end of each fiscal year and will not reflect subsequent grant amendments.
- Airport locations that received funds as part of a State Block Grant Program (SBGP) may have also received grants
 directly from the FAA prior to inclusion into the SBGP---specifically, during periods when the airport was designated as
 a primary airport and/or opted out of the SBGP. Because of this, the data available from this tool may not necessarily
 be complete for States participating in the SBGP.
- The grant data includes AIP entitlement and discretionary funds and Coronavirus Aid, Relief, and Economic Security (CARES) Act funds to increase the grant federal share to 100 percent. The data does not include CARES Act grants

awarded as economic relief to eligible U.S. airports affected by the prevention of, preparation for, and response to the COVID-19 pandemic.
