Aldermanic Actions

Chicopee Aldermen passed several financial orders at their meeting Tuesday night.

Appropriations approved were \$563 for the non-contributory pension of Police Capt. Leonel A. Remmillard who retires Dec. 1; \$1,875 for the installation of 275 feet of water pipe on Frederick St.; \$1,600 to the Floor Control Special Maintenance Account to replace the boiler at the Call St. pumping station; \$1,000 to the Extended Fire Alarm Circuit and \$200 to the Mayor's outside travel account.

The board removed from the table and passed three other financial orders including \$10,000 to the Highway Dept. for a rack body truck; \$1,600 to the City Property Committee for the heat and maintenance of the CROP building and the Fairview municipal building and \$10,000 to the Sanitation Dept. expense account.

A committee - of - the - whole meeting with the Fire Chief and members of the Fire Fighters' Assn. was called for Wednesday night to discuss the proposed rule and regulations for the Fire Dept.

Referred to the Zoning and Legal Affairs Committee were ordinances to restrict parking on Newbury St. by commercial vehicles to 30 minutes and to prohibit heavy duty trucks from using Rimmon Ave.

The 1969 election results were ratified by the board.

The Chicopee Electric Light Dept. was instructed to install a street light at Chicopee and State Sts.

Orders to remove a tree stump at 43 Benis St. and to trim the trees at Eton and East Main Sts. were referred to the Forestry Dept.

An order to rename Pendleton Ave., from Longwood Dr. to Duprat Ave., to Simard Dr. was passed and referred to the Engineering Dept. for the necessary preparations.

The board passed an ordinance prohibiting parking on the south side of John St.

Roger Choumiard was granted a license to deal in second hand goods at 69 Chicopee St.

The board passed a resolution commending the Chicopee High School soccer team for winning the state soccer championship.

Appropriations of the \$300 and \$57, respectively, were approved for the Fire Dept. and Health Dept. outside travel accounts.

Referred to the finance committee were requests for appropriations of \$4,641 to the Fire Dept. for the purchase of a vehicle for the Deputy Chief and \$5,750 to the Fire Dept. expense account.

Mayor's Administrative Aide Henry R. Mason Jr. was requested to appear at the board's next meeting to explain the request of \$1,500 for the

mayor's expense account. The Highway Dept. was instructed to install "no parking" signs at the bus stops on Front St. in front of the Kida Apts. and to remove the elevation of soil at the southeast corner of Carew and East Main Sts.

The board adopted a resolution to allow the Conservation Commission to use the 42-acre Buena Vista property for a nature center.

Other appropriations passed included \$2,093 to the damage account for Chicopee Comprehensive High School; \$2,189 from the Clyde St. construction account to the Leeds St. construction account and \$1,000 to the Library Salary Account.

Ramada Inn was granted a permit to erect a sign at 357 Burnett Rd.

The board referred to a committee - of - the - whole an amendment to the Chapter 20 which would strike the word "rank" and insert in its place "years of service as a regular member of the Police Dept., who holds the rank of captain."

The change pertains to the qualifications for the position of senior captain in the department which will be vacant upon the retirement of Leonel Remillard.
