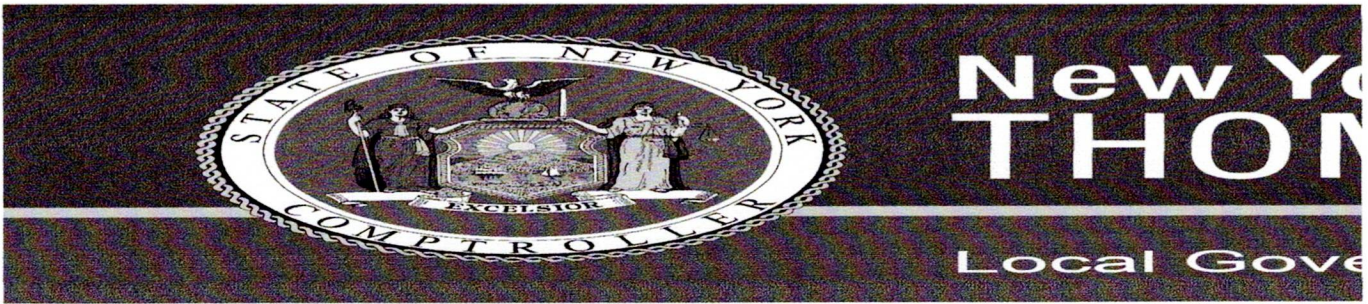

The Office of the State Comptroller uses the Fiscal Stress Monitoring System to examine the annual financial information reported by your Town.
