Code Enforcement Officer's Report: Wendy Lozo stated that Ray Orr verbally assured her that the home owner at the Eddy road location disconnected the electric at that location. Ray Orr only condemned the residence until a new septic system is installed.

Dog Control Officer's Report: Randy Akins reported 1 complaint about a dog howling, 3 dogs running at large, and 1 dog taken to the shelter in Rathbone.

Supervisor's Report: October 2021 paperwork is not completed at this time, it will be emailed to the Board and a hard copy will be filed in the Clerk's office when completed.

Highway Superintendent's Report: October 2021 monthly report was presented to the Board. Items of interest and work performed 10/21/21-11/10/21. Six days were spent completing the Fall grading. A headwall on a drive pipe on Helms road has been rebuilt and the ditches were cleared of debris. Water run off has been diverted at several driveways on Knowles road to keep the runoff water from running into the roadway. Several loads of gravel have been graded into roads that were washed out by the heavy rains on October 29th and 30th. Trees were removed from a large culvert on Hamilton road. A section of block wall had to be reset along Tucker road. A load of stone dust for patching potholes has been purchased from Steuben Crushed Stone. Three days have been spent patching potholes. Several days have been spent mixing salt with sand. The NYSDOT reimbursement forms have been sent in. Extreme Winter Recovery amount is \$43,384.78, Pave NY amount is \$47,542.85, and CHIPS amount is \$35,232.42 with a total reimbursement of \$126,160.05 to be received around December 15, 2021. The 1997 F450 bucket truck had the master cylinder, 2 calipers, and brake lines replaced. The 06 Sterling dump truck had dust shields replaced. The 01 Volvo dump truck and the excavator both had a hydraulic line replaced. The loader has been serviced. Motion was made by Paul Peck seconded by Noel Sylvester to accept and approve the Clerk's report through the Highway Superintendent's report.
