Ellie Flynn Podcast:

Regarding: UNDERWORLD BEHIND THE SCENES OF THE NCA: EPISODE 1 THE CRIME LORD

Ellie Flynn launched a new podcast in conjunction with the National Crime Agency, who have passed on to her not only misleading information but outright falsehoods at times. Later on this site, you will see a full breakdown of her podcast with relation to Robert Dawes. For now, let's just cover the biggest falsehood of all with regards to Mr. Dawes.

According to Ellie Flynn and her co-conspirators, Robert Hickinbottom from the National Crime Agency and Andy Young, the then prosecutor now turned barrister. Mr. Dawes, according to them, caused his own downfall by allegedly bragging about an import of 1.3 tons of cocaine. They demonstrated this by playing a small part of a recording of Mr. Dawes with a Colombian national and his chauffeur, a Venezuelan national, inside a hotel foyer in Madrid. This recording she has is also illegal because there is no registry in the case files in Spain or in France of any copy being handed over to her or the British authorities. In fact, Mr. Dawes and his legal team still cannot get access to this recording. So we must also question how they have this copy. But not only that, but the copy that the French have is inaudible and would not play at both Mr. Dawes' trials.

He alleges that the police doctored the version given to the French because it did not support the words that they had fabricated in the transcripts they had provided the French authorities with. According to them, Mr. Dawes is heard bragging about the 1.3 tons of cocaine. But in actual fact, this recording was recorded one year after the seizure of the said cocaine, and Mr. Dawes was repeating what he had heard and read online from the then Interior Minister, Manuel Valls. The National Crime Agency was asked by the Spanish Guardia Civil to listen to the recording and transcribe the English spoken words into text. They did this by fabricating a false document and placing words that would lead the French authorities to believe Mr. Dawes was claiming responsibility for the cocaine shipment. You can listen to the part of the podcast with regards to the recording inside the hotel to confirm this, without taking our word for it. It begins at 00:22:08 on the podcast and ends at 00:22:53 on the podcast.

Here is the written text, fabricated and presented by the National Crime Agency and used to convict Mr. Dawes in France without any other evidence. The part is on the podcast. Robert Dawes, British. Oscar Fernando Cuevas Cepeda, Colombian. Wilmar. Fernando Ortego, Rincon, Venezuelan.

That is the version presented to the Guardia Civil in English from the National Crime Agency. That was again doctored by the Guardia Civil, who added the Spanish speaking parts into text and transcribed the whole document into the Spanish language before passing it on to the Europol, who then transcribed it into the French language before passing it on to the French authorities, claiming that Mr. Dawes, after being asked if the cocaine shipment belonged to him by the Colombian national, Cepeda, answered yes. Remember, the French authorities have never even heard the name Robert Dawes inside their own investigations before and after the arrest of Mr. Wheat and the Italian nationals who arrived in Paris to collect the cocaine. It's not until they are contacted regarding the recording that they look into Mr. Dawes. Here is the actual text spoken on the recording you can listen to on the Ellie Flynn podcast with regards to the recording inside the hotel.

Robert Dawes, British. Oscar Fernando Cuevas Cepeda, Colombian. Wilmar Fernando Ortego Rincon, Venezuelan.

So, as you can hear and see, that when Mr. Dawes was asked if it belonged to him, he did not reply Yes, but in the version fabricated by the National Crime Agency, its written Yes.

Here is the version given to the Europol and then handed over to the French.

Robert Dawes, British. Oscar Fernando Cuevas Cepeda, Colombian. Wilmar Fernando Ortega Rincon, Venezuelan.

Robert Dawes: In cases it crashed. It is all over the news. You don't see it?

Cepeda: Yes, I know, I thought from Peru.

Robert Dawes: It is the biggest one they ever had.

Cepeda: And that belonged to you?

Robert Dawes: Yes, from Venezuela. The biggest one they ever did in Paris. Charles de Gaulle.

Cepeda: Ha ha ha! Both of them laughed.

Wilmar: Each person had an extra suitcase, each passenger, and they didn't know it.

You can see in this version the Spanish have added what Cepeda explains to Wilmar in Spanish but on the podcast version, it's impossible to make out what the Spanish words are that are spoken in the background.

The Guardia Civil just added what Dawes had already said, but into Spanish because the National Crime Agency told them, Cepeda explains to Wilmar in Spanish. Also, the National Crime Agency had added that Dawes was very proud. Even though this is not text, it's only their own thoughts. This is also repeated in the French version, D640, proving that the French did not listen to the actual audio, but rather copied the version of the Spanish and the British police transcripts. You have to understand that the audio recording has been hidden from Mr. Dawes and his defense team to this day. Over eight years after his arrest, he still has not had the opportunity to prove his innocence by listening to the recording.

Thanks to Ellie Flynn, the world can now see the lies fabricated by the National Crime Agency.

What the podcast does not point out is that the recording was totally illegal and not supported by the Spanish laws, and the police were using roving bugs where they remotely opened the microphone on a mobile telephone. And this is also totally illegal.

The document used to convict Mr. Dawes was D640. From the French case file. This document was made by copying the version of a combined fabrication made by the National Crime Agency and the Guardia Civil.

Mr. Dawes has always denied claiming responsibility for the 1.3 tons of cocaine. He explained that he only brought up the conversation about the news article he had read online, and especially the one by Manuel Valls. He stated the only reason he brought it up was that the chauffeur of the Colombian, Mr. Rincon, was from Venezuela, and maybe he had heard more details about it from his homeland.

Mr. Dawes explained, even though this was one year after the seizure in Paris, it was still spoken about quite a lot on the coast of Spain and in Nottingham because Mr. Nathan Wheat a British national from Nottingham who lived on the coast of Spain and had been arrested in Paris arranging the collection of the cocaine.

Mr. Rafael Nasr had informed the police on Wheat in April. 2013, but also added the lie that Dawes was also involved. Nasr had given this information in a trade for a passport for his illegitimate lovechild with a Russian prostitute, and adding Dawes' name was what the National Crime Agency wanted to hear, so he fed them what they desired.

When I listen to the recording on the podcast of Ellie Flynn, it's quite clear Mr. Dawes is not bragging about the shipment. He's merely pointing out what was on the news to jog the memories of Cepeda and Rincon, to see if they had further information from Venezuela.

What you also must understand, and contrary to what the podcast leads you to believe, this recording was recorded on the 23rd of September 2014, one year after the seizure. So all the information was in the mainstream news. But on the 5th of March 2015, the Guardia Civil closed their more than two years investigation against Dawes, with no further judicial action to be taken. This proves that any information that was recorded inside the hotel was not of any importance, and did not denounce any corrupt officials, as stated by Ellie Flynn, or any information that could be used to bring a case against Mr. Dawes. This is evident with the Spanish judge closing the investigation after more than two years, with no further action to be taken.

It's not until after this closing of the investigation by the Spanish judge that the National Crime Agency and the Guardia Civil concocted the plan to mislead the French into thinking that Dawes was the boss behind the 1.3 tons of cocaine.

You would have also heard on the podcast that the Spanish police denied ever making a recording, and Rob Hickinbottom stated he was perplexed at this because he had told the prosecutors he had heard the recording on the invitation of the Spanish. The reason this Spanish officer denied making the recording is because he knew it was totally illegal to make such a recording under Spanish law.

Something else that would shed light on the inconsistencies of the version of the Hickinbottom and Young is that the recording was made on the 23rd of September 2014, yet it is not until the 2nd of November 2015 it is handed over to the French authorities. Why would they hang on to this miraculous piece of evidence for almost 14 months? The truth is, is that it had no evidential value and it's not until after the judge in Spain decided to close the Spanish investigation that the police went to work on fitting Mr Dawes up. Here you will find some quotes from the case file in France that prove it only arrived in France on the 2nd of November 2015:

"The minutes from the 2nd of November 2015, number D619, indicate that on that date, the disputed sound system was sealed. According to this process-verbal:

"Considering article 97 of the code of penal procedure, Having regard to the delivery by the Spanish judicial authorities of Madrid (Court N°2) of a document attached to a DVD containing the sound system of the 23rd of September 2014 thus worded 'HOTEL VILLAMAGNA'.

Being in our office, we seized the said DVD and placed it under seal with the number: JUGE CRISONORISATION-23/09/14;

Let's order the deposit of this seal at the registry of the seals of the TGI of Paris" (D619/2).

Therefore, on the 2nd of November 2015, the disputed recording, provided by the Spanish authorities, was sealed, and there is no indication in the placement report that a working copy had been made previously.

Additionally, exhibit D917/22 reveals that on the 9th of November 2015, this seal was deposited in room 2015-OM of the Paris Tribunal de grande instance.

However, as indicated in D639, it was only through an order on the 19th of November 2015 that the examining magistrate appointed an expert and assigned him the task of "listening, transcribing, and providing a French translation of the English language recordings contained in the CD, which contains the copy of the recording made by the agents of the central operational unit of the Guardia Civil at the Villamagna Hotel in Madrid on the 23rd of September 2014" (D639/4).

The inconsistency is glaring! Given that this recording had been sealed on the 2nd of November 2015 and was only mentioned on the 19th of November 2015, it is evident that the expert could not have had access to the sound recording from the 23rd of September 2014 at the Hotel Villamagna in Madrid.

To be convinced of this, it is sufficient to highlight that the investigating magistrate never ordered the breaking and subsequent reconstitution of the seal.

Furthermore, it is not insignificant to note that there is no report in the case file describing the actions undertaken by the experts during their mission, as required by Article 166 of the Code of Criminal Procedure.

In all aspects, it is therefore established that the expert could not have had access to the seal labeled "JUGE CRI-SONORISATION-23/08/14."

The above is based on a complaint made by Mr Dawes through his lawyers with regards to the transcript D640 that was used to convict him. He alleges that the French expert never had access to the recording and basically copied the version made by the National Crime Agency and the Guardia Civil, the consequences are alarming.
