



Fee Structure Promoters Yearly Licensing Fees Pro/Am

Yearly Licensing Fee- Event sanctioning fees paid per event (see below)

New- \$750 (New promoters must secure a Bond) Renewal of previous license- \$500

Event Sanctioning Fees

Pro/Am Event Sanctioning Fees-

All sanctioning fees due upon approval of event (non-refundable) Promoter must also be licensed (see Licensing Fees above)

Single event Pro/Am (Maximum 15 bouts) = \$750

Tournament- To be determined based on regulations, style and size of tournament *Note: We will not sanction more than 15 bouts on any single event unless it is a tournament format!

Event Officials Fees (Using WBC Officials)

Officials Fees- Due at event start time given to supervisor

Supervisor- \$350 per day (day before weigh in requires 2 days)

Referee (1-2)- \$350

Judge (2-3)- \$250

Timekeeper (1)- \$200

Inspectors (4)- \$175

MD Doctor- \$350 per day (day before weigh ins require 2 days)

Insurance

Insurance Requirements- Due no later than 48 hours prior to event

Event Insurance- Liability insurance equal to 1 million per occurrence 2 million aggregate

Fighter Medical Insurance- Amateur minimum \$20,000 short term medical insurance required. Professional minimum \$50,000 short term medical insurance required.





Fee Structure Contender Series - C Class (all boxers under 5 fights)

Contender Series Sanctioning Fees- \$350 Officials Fees- Due at event start time given to supervisor

Supervisor- \$200 per day (day before weigh in requires 2 days) 2 Days= \$350

Referee (1-2)- \$200 Judge (2-3)- \$150

Timekeeper (1)- \$100

Inspectors (4)- \$100

MD Doctor- \$350 per day (day before weigh ins require 2 days)

Medical Requirements-

Medical Staffing Requirements-

All events require one MD or DO 2 EMT's and an ambulance on site at the event

Amatueur- Yearly medical examination and blood test to check for HIV and Hep B/C

Professional- In consultation with the local commission and medical teams, fighters sanctioned for a WBCMuayThai professional bout including regional, national, and state championship should undertake medicals to obtain clearance to fight, which should include the following (where applicable)

- an MRI of the brain without contrast is valid for three years unless required by a ringside physician
- a dilated ophthalmological eye examination, administered by a licensed ophthalmologist, which is good for one year
- blood work: Human Immunodeficiency Virus (HIV) 1&2, Hepatitis B Surface Antigen, Hepatitis CAntibody which is good for the whole calendar year, i.e., From 01 January to 31 December)
- complete physical examination, which is suitable for one year
- fighters of 40 years and over must also submit a neurological exam administered by a neurologist
- fighters of 40 years and over must also submit an EKG.
- Depending on the EKG, they may also have to submit a stress test
- female fighters must submit a pregnancy test 14 days before the date of the championship





Fee Structure

New Promoters Bond Requirements- Due for all new promoters

Professional promoters are required to secure a bond in the amount of \$50,000 or in an amount determined by WBC Muay Thai USA to assure the faithful performance of the promoter. Amateur promoters are required to secure a bond in the amount of \$5,000 or in an amount determined by the WBC Muay Thai USA. We may require an increase in the bond amount on a show-by-show basis depending on the financial obligations incurred for a specific event.

Amateur/Professional- \$68 Includes WBCMT Patch, Passbook, yearly national license

Cornerman Yearly National Licensing Fee-

\$68 Includes WBCMT Patch, Scoring guidebook, yearly national license

Officials Yearly National Licensing Fees-

ALL Officials- Includes Small and Large Patches Scoring Guideline booklet

Supervisor- \$198 Includes Large and Small Patch plus scoring guidebook and referee pocket guide

Referee- \$198 Includes Large and Small Patch plus scoring guidebook and referee pocket guide

Judge- \$129 Includes Large and Small Patch plus scoring guidebook

Inspector- \$98 Includes Small Patch, Scoring guidebook

Timekeeper- \$98 Includes 2 Small patches

Your order must be accompanied with a title bout approval form signed by the Chairman Mr. Bryan Dobler. No order will be accepted without it. The fees for all belts and awards will be paid directly to WBC Muay Thai Headquarters in BKK.
