Dear Members of the Permanent International Media Monitoring Mission on Disinformation about Ukraine and the Ukrainian diaspora!

Following our previous notice of 8 May 2021, we continued our organizational work and wish to update you concerning same.

Leadership of the Mission

On 16 May 2021, the Board of Directors of NGO "Ukraine-2050" officially confirmed the creation of the Permanent International Media Monitoring Mission on Disinformation about Ukraine and the Ukrainian diaspora (the "Mission") and elected the following Leadership of the Mission:

• Head of the Mission: Eugene Czolij;

• Executive Director: Myron Nayda;

• Chief Analyst: Roman: Panchuk; and

• Director of Strategic Communications: Peter Sztyk.

Official start of the media monitoring

We are very pleased to inform you that the official start of the Mission will be on 4 June 2021.

On 4 June 2021, we will hold two press conferences at the Ukraine Crisis Media Center, at 14:00 in Ukrainian and 14:45 in English (Kyiv time), to announce the official start of the Mission,

Composition of the Mission

As of this day we have 163 members of the Mission from 55 countries, who will be media monitoring in 41 languages.

The monitors are from the following 55 countries (in alphabetical order):

Argentina, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Bulgaria, Canada, Croatia, Czech Republic, Cyprus, Denmark, Estonia, Finland, France, Georgia, Germany, Great Britain, Greece, Hungary, India, Ireland, Israel, Italy, Japan, Kazakhstan, Latvia, Lebanon, Lithuania, Luxembourg, Malta, Moldova, Mozambique, New Zealand, Northern Macedonia, Norway, Paraguay, Poland, Portugal, Romania, Russian Federation, Serbia, Singapore, Slovak Republic, Slovenia, South Africa, Spain, Sweden, Switzerland, The Netherlands, Turkey, United Arab Emirates, United States of America and Ukraine.

The 41 languages covered for monitoring are (in alphabetical order):

Arabic, Austro-Bavarian, Belarusian, Bosnian, Bulgarian, Crimean-Tatar, Croatian, Czech, Danish, Dutch, English, Estonian, Finnish, French, Georgian, German, Greek, Hebrew, Hindi, Hungarian, Italian, Japanese, Kazakh, Latvian, Lithuanian, Luxembourgish, Macedonian, Maltese, Montenegrin, Norwegian, Polish, Portuguese, Romanian, Russian, Serbian, Slovak, Slovenian, Spanish, Swedish, Turkish and Ukrainian.

We have monitors from all the G7 countries and all the 27 EU member states.

We wish to have monitors from all the 30 NATO member states. We now have monitors from 27 NATO member states and are still looking for monitors from 3 NATO member states, namely Albania, Iceland and Montenegro.

Online meeting for members of the Analytical team of the Mission

As mentioned in our Applications, the Mission has two teams:

- (A) a team that monitors media, social networks and other information resources and generates online reports on articles that disseminate disinformation about Ukraine and the Ukrainian diaspora; and
- (B) a team that analyzes the data of the online reports, draws conclusions and takes effective measures to help counter such disinformation (the "Analytical team").

We held an online meeting with our Analytical team (Team B) on 24 April 2021 to divide the work among the members of this team and identify specific procedural issues regarding the analysis of disinformation materials.

We are asking all the members of our Analytical team (Team B) to also join the team of monitors (Team A) and to send us a revised Application indicating that you are willing to be part of both teams by 4 June 2021 at the following email address: ngo@ukraine-2050.org.
