Lawful Notice and Warning:

Federal law provides that it is a crime to violate the Rights of a citizen under the color-of-law by means of extortion, coercion, war of attrition (or breach of the peace).

You shall be arrested for this crime and you shall also be held personally liable for damages and/or injury.

Attempting to cause a people to do any thing by telling said man or woman that such action is *required* by law, when it is *not required* by law, **shall be a felony**, including - *but not limited to* - the following United States Codes:

18 USC §242 provides that whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States ... shall be fined under this title or imprisoned not more than one year, or both.

18 USC §245 provides that Whoever, whether or not acting under color of law, intimidates or interferes with any person from participating in or enjoying any benefit, service, privilege, program, facility, or activity provided or administered by the United States; [or] applying for or enjoying employment, or any requisite thereof, by any agency of the United States; shall be fined under this title, or imprisoned not more than one year, or both.

18 USC §2381 provides that Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, **is guilty of treason and shall suffer death.**

42 USC §1983 provides that every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or the District of Columbia, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress.

DUE NOTICE AND WARNING: you shall be in violation of Federal Law and persisting with your demand shall lead to your arrest and/or civil damages. Also understand that the law provides that you shall be held personally responsible and liable, as well as your company and/or agency.

You shall cease and desist with your demand and to seek *personal* legal counsel if you do not understand the law.
