Mr. McCoy has requested board input and legal advice about the possibility of trading one of the Authority's available trucks for tree work. Mr. McCoy will obtain bids from Mile High Tree Care to cross check the value of work done. Mr. McCoy will work with Ms. Graham to create a contract to transfer the truck once ready to proceed. Mr. McCoy has recently received calculations to determine proper pre-cast culvert size for

the crossing on W. 80th Ave. near the railroad tracks. Jefferson County Road and Bridge has inspected that same culvert and referred it out to CDOT for recommendations of repair or replacement. CoorsTek remediation has been completed. Staff is completing final ditch preparation to start water. Mr. McCoy also noted that tags have been placed on headgates to notify users that tampering with set collars may result in shutting down water.
