MAINTENANCE/CIP UPDATE

General

Maintenance

Mr. McCoy has met with ERC and CoorsTek regarding the completion of soil remediation and the possibility of relocating the ditch during the development of the CoorsTek property. Mr. McCoy stated that Golden

continues to explore the possibility of building a secondary Peaks to Plains trail that may require placement within the ditch easement. Additionally, Golden has inquired about the possibility of the Authority partnering with

the city for grants to install a fish screen directly upstream of the ditch headworks. At this time the Authority will work with the city but will not be partnering. CDOT has provided 90% drawings for the emergency replacement of the culvert under Indiana south of W. 80th Ave. Mr. McCoy and ERC will meet with CDOT 9/9 to discuss those drawings. The City of Arvada currently has a sanitary sewer crossing in review with the Authority.
