Mr. Wulff will document the repairs made by CDOT for the project file. Mr. McCoy has signed the paperwork for XCEL relocation on Cheyenne. Coortek is set to have the liner installed the week on 3/10 and the remediation is expected to be completed on time. Mr. McCoy has given ERC direction to perform an informal hydraulics analysis on W. 80th Ave. near the rail road to begin
