General

Maintenance

Mr. McCoy has received almost complete drawings for the replacement of the culvert under Cheyenne Street in Golden. Mr. McCoy is awaiting final details to redesign XCEL gas that currently runs over the culvert prior to releasing for bid. CDOT has replaced the failed culvert under Indiana near W. 80th Ave. CDOT is wrapping up construction on the aprons, grading, and guardrails. Staff is finishing up ditch repairs in Westwoods. Mr. McCoy has met with ERC to initiate an EAP for the replacement repairs of the culvert under W. 80th Ave. near 12325 W. 80th Ave. Mr. McCoy will continue pursuing an emergency contractor and sourcing a pre-cast box culvert. Mr. McCoy will follow-up with Jeffco Road and Bridge. Ms. Moon will notify Northglenn counsel. The Board of Directors agrees that this culvert takes priority over Cheyenne and recommends suspending the replacement of Cheyenne should the W. 80th Ave. culvert require emergency replacement.
