## **New Business:**

**Review and Amending of Article VIII – General Provisions:** Motion Isley, support to accept Sections 8.01, 8.02, 8.03 as amended. **Motion failed due to lack of support.** 

The following are recommended amendments to Article VIII – General Provisions of the Working Document of the Zoning Ordinance:

- Section 8.01, A Access to Public Streets: Strike Agriculture District in first sentence
- Section 8.01, B Access to Public Streets: In the second sentence, add "street" after "public", then add "or public easement" before "or private easement"
- Section 8.02, A Adult and Child Day-Care Facilities: Add under Section 8.02, A, "1. The
  proposed use of the residence for Adult Family Day-Care Homes and Child Family DayCare Homes shall not change the essential character of the surrounding residential area
  and shall not create a nuisance in fact or law relating to vehicular parking, noise, or
  additional congestion in excess of residential uses in the district."

- Section 8.02, B1 Adult and Child Day-Care Facilities: Strike all of paragraph B1 and replace B1 with "The property is maintained in a manner that is consistent with the character of the neighborhood."
- Strike "Village Residential Districts" throughout the working document of Article VIII –
   General provisions. (This district does not yet exist)

## Recommended Amendments to Article IV – Zoning Districts Regulations of the Zoning Ordinance #11-2020:

- Section 4.1.2 Permitted Uses (AG District): Add "J. Adult Family Day-Care and Child Family Day-Care Homes"
- Section 4.1.3 Special Use (AG District): Add "U. Adult Day-Care Homes"
- Section 4.2.2 Permitted Uses (AG Residential): Add "H. Adult Family or Child Family Day-Care Homes"
- Section 4.2.3 Special Approval Uses (AG Residential): add "N. Adult Day-Care Homes"
- Section 4.3.2 Permitted Uses: Mobile Homes: After "Mobile Homes" add "Adult Family or Child Family Day-care Homes"
- Section 4.3.3 (Mobile Home Residential District): Change Section 4.3.3 to "Special Approval Uses" and move the original wording of Section 4.3.3 to a newly created Section 4.3.4. Under the new Section 4.3.3, add "A. Adult Group Day-Care Homes"

The Planning Commission will resume their review at Section 8.02, C – Adult and Child Day-Care Facilities.
