Palmyra Township Regular Board Meeting Minutes June 8, 2021

Meeting called to order at 7:01 p.m. by Supervisor Dave Pixley at the Palmyra Township Hall, 6490 Palmyra Rd.

Public Comment:

- Nancy Seeburger asked if there will be another Planning Commission meeting for the SES
 Ordinance. Supervisor Pixley explained that there will be a meeting when the Lenawee County
 Planning Commission returns the SES Ordinance to the Board.
- Tom Creque of Sylvania, OH, stated that he is in support of the Township SES Ordinance. He also stated that solar will add income diversification to the farmers' portfolio, and solar also offers alternatives to land use, enabling family farms to keep their farms. He also added that solar will produce much needed revenue for the township.
- John Tuckerman of Riga stated that he strongly supports property rights, and that he has issues
 with people who only have an acre of land and want to tell large land owners what to do with
 their land. He also added that the County and Township will benefit from the additional
 revenue, and both County and the Township need an alternative/new tax base.
- Dan Sauter of Palmyra Township stated that the 50-foot setback is too close to adjoining properties, and he is concerned about a security fence being too close to the property lines.
- Eileen Creque of Sylvania, OH stated that she is in favor of solar energy systems in Palmyra Township. She added that it will be a huge source of revenue, generating a sustainable source of income for the Township.
- Henry Smith of Blissfield stated that he is in support of property rights and a strong advocate of
 the freedom to do what you like with your property. He added that SES would provide
 opportunities for the Township and benefits for the fire department and schools.
- Don Keller of Sylvania, OH commented that if people want more setback, then they should buy more property.

- Bill Reed of Palmyra Township stated that he doesn't see a problem with SES. He added that people have the right to do what they want with their property, and if people want more property, then they should buy it.
- Nancy Seeburger of Palmyra stated that she is concerned that the SES Ordinance does not regulate the amount of coverage on property. She also stated that the Zoning Ordinance has controlled land use for many years.
- Matt Drennan of ESA Solar explained that ESA Solar is here to work with the Township, and the
 company desires to be good to the neighbors. Matt also added that SES can only be sited in
 certain spots, and if the SES Ordinance passes, they will work with the community.
- Greg Sauter of Palmyra Township stated that a solar energy farm is not agriculture, it is an industry. He added that he is opposed to SES, and the community should also reap the benefits as well as the farmers.
- John Tuckerman of Blissfield stated that if the tax base of SES comes to the Township, then the community will benefit.
- Mark Knoblauch of Palmyra Township stated that he has worked very hard for his farm, and therefore, believes in property rights because he has earned them.
- Dan Sauter of Palmyra Township stated that he has a problem with the 50-foot setback and not solar. He added that property owners have the right to have greater setbacks.
- Jeff Ehlert of Blissfield Township believes the 50-foot setback is consistent with other setbacks within the Palmyra Township Zoning Ordinance. He also stated that the Township will benefit from the tax revenue that solar systems will generate.
- Paul Vergote of Blissfield, owner of property in Palmyra Twp., stated that people need to take a step back and consider the future. He added that everybody needs money, and the revenue generated by SES would help sustain the fire department.
- Laura Brown, Palmyra Twp. Planning Commission member, stated that she voted "no" on the SES Ordinance because she wanted an opportunity for the Planning Commission to make changes on the SES Ordinance before it was sent to the Lenawee County Planning Commission. She stated that solar will not offset energy rates, and tax revenue is not a valid criterion to allow SES in the Township. She also stated that if the SES Ordinance goes to referendum vote, it will be the Palmyra Township voters who vote and not those who live outside of Palmyra Township.
- Dan Sauter commented that the setback should be far enough from adjoining property lines in order to properly maintain the SES farm.
- Paul Vergote stated that he would like the Township Board to accept a reasonable SES
 Ordinance.
