- Housing Lenawee: Lynn Punnett from One Lenawee explained that Housing Lenawee is
 a subcommittee that addresses issues related to the quality of life in Lenawee County,
 and a primary need is housing. A housing study reveals that there is a need for new
 housing in Lenawee County. A Target Market Analysis is used to provide data that is
 used to create a housing strategic plan. This plan would involve Lenawee County

 - The property will be deeded to Palmyra Township, by way of a Warranty Deed as well as a policy of title insurance being purchased by the Estate of Lee Ellen Driggs.

 Prior to Palmyra Township taking possession of said property, the Estate of Lee Ellen Driggs by and through Keith Knierim will secure the well that is located on the property.
