Communications:

- Ryan Carpenter RRD Project Manager, EGLE Adrian Oil Burner Remediation: Ryan reported that the Adrian Oil Burner operated from 1963 to 2000. In 1984, there was an underground tank that released gasoline into the soil. Adrian Oil Burner began clean up, but in 2014, the State of Michigan discovered that it was not cleaned up. It was discovered that approximately 30,000 gallons of gasoline was still in the soil, and was 30 feet deep. The gasoline eventually leached into the ground water, and is submerged under the water. The State has been consistently sampling the ground water, and Ryan reported that only one well is affected. Ryan stated that EGLE is monitoring the monitoring network twice a year. He stated that the ground water is treated before it is discharged back into the County drain. He said that the remediation will be expanded, and they are in the process of getting a permit from the Lenawee County Drain Commission to install an underground drain line that will run southeast along US 223, then southward under US 223, emptying into the Lenawee County drain in a nearby field.
- Great Lakes Community Action Partnership: Amy Hatfield and Louis Vinson III presented to the Board, in regards to municipal water in Palmyra Township, the Rural Community Assistance Program, which can help communities access safe drinking water supplies and provide assistance in grants and loans, as well as providing other services. Louis reported that they will be working with Madison and Palmyra officials to get water to Palmyra Township.
