#### 2. Financial Review

- a. The board presented their recommendation on a \$10 increase in the fee noting that it had not been increased since the special increase implemented in 2012 by the board at the time, going from \$50 to \$100
- b. The reserve fund of \$19,203.55 has been utilized for the difference between receipts and expenses for the past 2 years
  - i. 2017's deficit was \$2,526 and 2018's deficit was \$1,169
- c. No other specific questions on the budget were asked
- d. See election for voting results on proposed fee increase

### 3. 2018 accomplishments

- a. Plant replacements were made at the entrance
- b. Jessica Goodman noted the surveys and proposed rule changes sent out to homeowners
  - i. Trash can enclosure rule passed by a majority of homeowners and was filed with the county on February 8, 2019
  - ii. Solar panel installation survey and vote
    - 1. Majority of homeowners voted for panels to be installed on the roof only
    - 2. Guidelines presented on the roof installation are currently being voted on with vote deadline of February 18, 2019

- a. Wall tuck-pointing and cleaning
- b. Existing rules to be recorded with St. Charles County

a. Paul Greg withdrew from consideration to the open board position
