- Be a homeowner in Drovers Crossing for **at least 3 years**.
- Be in **good standing** with the HOA, which means:
 - No outstanding balance on your account.
 - Any prior violation notices must be addressed to the satisfaction of the board before the election.

The **Self-Nomination Form** must be submitted with a letter containing information about yourself, your qualifications, and why you are seeking this position. **We will only accept self-nominations**, and incomplete or improperly filed forms will not be considered.
