## ADDITION OF A RULE UNDER THE CONDITIONS, RESTRICTIONS, PROVISIONS AND TRUSTEESHIP FOR THE SUBDIVISION KNOWN AS DROVERS CROSSING PLAT #1, ST. CHARLES COUNTY, MISSOURI

WHEREAS, the CONDITIONS, RESTRICTIONS, PROVISIONS AND TRUSTEESHIP FOR THE SUBDIVISION KNOWN AS DROVERS CROSSING, PLAT #1, ST CHARLES COUNTY, MISSOURI (hereinafter referred to as the "RESTRICTIONS") was executed December 14, 1978 and recorded in Book 825, Page 254 in the Records of the County of St. Charles Missouri; and imposed on plats 1-3; and

WHEREAS, the community wishes to give notice of a rule adoption.

WHEREAS, Drovers Crossing Restrictions #30 in the RESTRICTIONS allows for Rulemaking and Cancellation of Unreasonable Rules from time to time by and upon:

- a) Before any Rule adopted by the Trustees can become effective said Rule shall be put to a vote of the owners;
- b) Trustees shall set a vote on whether the Rule should be approved or cancelled:
- c) A vote with at least 30 days' notice containing the procedures for voting in person, by mail or by proxy;
- d) If at said scheduled vote 60% of the Owners actually voting in person, by mail or by proxy vote to cancel the Rule, said Rule shall be nullified; and
- e) Adoption of Rule if there is less than 60% negative vote of the Owners voting in person, by mail or by proxy at the meeting.

## WHEREAS, the adoption of this Rule consisted of:

a) The Rule was put to a vote of the owners;

b) The Trustees set a meeting for the vote of the Rule;

c) Proper notice containing the procedures for voting were given;

d) Adoption of Rule because there was less than 60% negative vote of the Owners voting in person, by mail or by proxy at the meeting.

WHEREAS, the undersigned Trustees and Owners of the majority of the lots of the entire Drovers Crossing, deem it in the best interest of the Association to adopt the new Rule, RULE NO. 11 TRASH ENCLOSURES

NOW THERFORE, RULE NO. 11 TRASH ENCLOSURES is adopted as follows:

Prior approval is required before any trash enclosure shall be erected or maintained on any lot. The Board of Trustee's review of all enclosure requests are considered final.

## Restrictions:

- Must be made of vinyl that match the color of the home's trim or shutters.
   Landscape is not an approved form of enclosure.
- Must be 60" in height to fully cover trash receptacles.
- Must be on the side or rear of home. Cannot be on the street side.
- No current types of enclosures will be grand-fathered in.
