### THE TERMS & CONDITIONS

### DEPOSITS, PAYMENT & MINIMUM SPEND

To confirm a booking at Salt Bar, clients must complete the required booking form and pay any deposit or minimum spend as outlined in the booking form's Terms  $\delta$  Conditions. A valid credit card is required upon confirmation, even if the deposit is paid via direct debit.

Final guest numbers must be confirmed 14 days prior to your booking. These confirmed numbers are final and will be charged in full. If the agreed minimum spend is not met by the conclusion of your event, a venue hire fee will be applied to cover the shortfall.

#### CANCELLATION

Cancellations must be submitted in writing to the Events Manager. Deposits will be refunded if the cancellation is received at least 14 days before your booking date.

For bookings in November or December, cancellations within 14 days of the booking date will forfeit 50% of the deposit.

Salt Bar reserves the right to move or cancel any booking due to circumstances beyond our control, including but not limited to severe weather, safety concerns, or required maintenance.

### FOOD & BEVERAGE

Menu and beverage selections must be finalised 14 days prior to your event. Failure to confirm selections by this date may result in limited options. All menu items and beverages are subject to seasonal and supplier availability.

### THE TERMS & CONDITIONS

#### RESPONSIBLE SERVICE OF ALCOHOL

Salt Bar complies with the Liquor Act and strictly follows Responsible Service of Alcohol (RSA) guidelines. We reserve the right to refuse service or remove any guest who is deemed intoxicated, behaving inappropriately, or otherwise breaching venue rules. No refunds will be issued for guests removed from the venue.

All guests aged 18 years or over must carry valid photo identification.

#### **CELEBRATIONS**

Salt Bar accepts bookings for 18th and 21st birthdays. However, as we operate under a Bar Licence, all minors must be accompanied by a parent or legal guardian at all times. For events attended by minors, they must vacate the premises by 9:00pm.

#### MUSIC & ENTERTAINMENT

As Salt Bar is an open venue, guests are not permitted to supply their own music, DJs, or amplified entertainment. Music and entertainment are provided by the venue to suit all guests and the general public, unless doing a venue takeover.

### **DECORATIONS & BYO**

All decorations must be pre-approved by the Events Manager. Costumes, themed props, or paraphernalia are not permitted unless otherwise approved.

Outside food and beverages are not permitted, with the exception of celebration cakes, which must be arranged in advance. A cakeage fee of \$2.50 per person applies.

### THE TERMS & CONDITIONS

#### **MINORS**

The attendance of minors must be approved by the Events Manager prior to booking. Minors are permitted in the venue only until 8:00pm and must be accompanied by a parent or legal guardian at all times.

Upon arrival, minors must be presented to a manager and will be issued a wristband to be worn at all times while on the premises.
